

Scope

Dead Sea Discoveries (DSD) is an international journal dedicated to the study of the Dead Sea Scrolls and associated literature. The journal is primarily devoted to the discussion of the significance of the finds in the Judean Desert for Biblical Studies, and the study of early Jewish and Christian history. *Dead Sea Discoveries* has established itself as an invaluable resource for the subject both in the private collections of professors and scholars as well as in the major research libraries of the world.

Online Submission

Dead Sea Discoveries uses online submission only. Authors should submit their manuscript online via the Editorial Manager (EM) online submission system at: <u>editorialmanager.com/dsd</u>. First-time users of EM need to register first. Go to the website and click on the "Register Now" link in the login menu. Enter the information requested.

When you register, select e-mail as your preferred method of contact. Upon successful registration, you will receive an e-mail message containing your Username and Password. If you should forget your Username and Password, click on the "Send Username/Password" link in the login section, and enter your first name, last name and email address exactly as you had entered it when you registered. Your access codes will then be e-mailed to you.

Prior to submission, authors are encouraged to read the 'Instructions for Authors'. When submitting via the website, you will be guided step by step through the creation and uploading of the various files. A revised document is uploaded the same way as the initial submission. The system automatically generates an electronic (PDF) proof, which is then used for reviewing purposes. All correspondence, including the editor's request for revision and final decision, is sent by e-mail.

Double-blinded Peer Review

Dead Sea Discoveries uses a double-blind peer review system, which means that manuscript author(s) do not know who the reviewers are, and that reviewers do not know the names of the author(s). When you submit your article via Editorial Manager, you will be asked to submit a separate title page which includes the full title of the manuscript, plus the names and complete contact details of all authors. This page will not be accessible to the referees. All other files (manuscript, figures, tables, etc.) should not

contain any information concerning author names, institutions, etc. The name of these files should also be anonymized.

Tables, illustrations and other figures should be uploaded as separate files.

File Format

Please upload the manuscript as a source file such as .doc, .rtf or .mellel. If your article contains non-Roman scripts (e.g., Greek, Hebrew) or diacritics, please also submit a pdf file of the manuscript in which all non-Roman characters are displayed correctly.

Tables should be submitted as Word files, and figures should be submitted in high resolution (300 dpi or higher) .jpg or .tif files.

Submission Requirements

Language

Manuscripts should preferably be written in English (British or American; spelling should be consistent throughout); contributions in French or German will occasionally be accepted. Articles in English should follow the guidelines of *The SBL Handbook of Style*, 2nd edition, for citations of ancient texts, bibliographical references, and abbreviations. Articles in French and German should approximate this style in as far as possible.

Non-Roman Scripts

The editor may remove unnecessary references to or quotations of Hebrew or Greek texts or words. Hebrew text (for example in quotations from the Hebrew Bible) should only be vocalized where the vowels are relevant for the discussion in the article.

Manuscript Structure

Except for references to the Dead Sea Scrolls, accepted articles should follow the style of the *SBL Handbook of Style* (second edition), and, for cases of style that are not covered by the *SBLHS*, the *Chicago Manual of Style*; <u>chicagomanualofstyle.org/contents.html</u>.

Abstract and Keywords

Articles should include an abstract of 100-150 words, and a list of ca. 4 to 7 keywords. The abstract and keywords should always be written in English, regardless of the language in which the article is written.

Headings

Three levels of headings are usual. All are flush left:

1 The First Level Heading is Bold

They have two blank lines above and one below.

1.1 *The Second Level Heading is Bold Italics* They have one blank line above and none below.

1.1.1 The Third Level Heading is RomanThey have one blank line above and none below.

Bibliography

The journal uses footnotes and a bibliography (reference list including all works cited in the notes) at the end of the manuscript. The bibliography should be formatted according to the *SBL Handbook of Style*, 2nd Edition. References to online publications, including Pre-Published Journal Articles, should include the DOI (digital object identifier); see the *SBL Handbook* 6.1.6. References to bibliographical items written in Hebrew should use the non-Hebrew language title that appears in the book or journal, indicating the original language in parentheses. If such a non-Hebrew language title is not provided, transliterate the title.

Citation in the Footnotes

In the footnotes, use shortened citations, even at first mention. The short form should include enough information to remind readers of the full title or to lead them to the appropriate entry in the bibliography. The short form generally consists of the last name of the author and the main title of the work cited, usually shortened if more than four words, with, where appropriate, reference to specific page numbers. For the form of short citations see the examples in *SBL Handbook*, 6.2-3, or the guidelines in *The Chicago Manual of Style*, 16th edition, 14.24-28.

- In general, one should follow the system used in the later volumes of the DJD series: columns of manuscripts are indicated by capital Roman numbers, fragments and lines by Arabic numbers, and columns of fragments by small Roman numbers, all without commas. For example: 1Q22 I 5, 1Q36 25 3, 1Q27 1 ii 5.
- 2. In the case of large "non-biblical" manuscripts, such as 1QS, 1QM, 1QH^a, 1QpHab, 1QapGen, the Copper Scroll, and 11QT^a, one should use the system of column and line both in Arabic numbers, separated by a colon. For example, refer to 11QT^a 38:12–39:9 instead of 11QT^a XXXVIII 12–XXXIX 9. One should also use this system for large Cave 4 and 11 manuscripts, if the number of columns in the manuscript is reconstructed by the DJD editors. For example, refer to 4QS^c 5:1 instead of 4QS^c V 1.

Bibliographical references to contributions in DJD editions may be abbreviated as follows: E. Schuller, DJD 29:77–232.

Publication

Proofs

Upon acceptance, a PDF of the article proofs will be sent to authors by e-mail to check carefully for factual and typographic errors. Authors are responsible for checking these proofs and are strongly urged to make use of the Comment & Markup toolbar to note their corrections directly on the proofs. At this stage in the production process only minor corrections are allowed. Alterations to the original manuscript at this stage will result in considerable delay in publication and, therefore, are not accepted unless charged to the author. Proofs should be returned promptly to the editor within the period requested.

E-Offprints

A PDF file of the article will be supplied free of charge by the publisher to authors for personal use. Brill is a RoMEO yellow publisher.

The Author retains the right to self-archive the submitted (pre-peer-review) version of the article at any time. The submitted version of an article is the author's version that has not been peer-reviewed, nor had any value added to it by Brill (such as formatting or copy editing). The Author retains the right to self-archive the accepted (peer-reviewed) version after an embargo period of 24 months. The accepted version means the version which has been accepted for publication and contains all revisions made after peer reviewing and copy editing, but has not yet been typeset in the publisher's lay-out. The publisher's lay-out must not be used in any repository or on any website (brill.com/resources/authors/publishing-

Consent to Publish

Transfer of Copyright

By submitting a manuscript, the author agrees that the copyright for the article is transferred to the publisher if and when the article is accepted for publication. For that purpose the author needs to sign the **Consent to Publish** which will be sent with the first proofs of the manuscript.

Open Access

Should the author wish to publish the article in Open Access he/she can choose the Brill Open option. This allows for non-exclusive Open Access publication under a Creative Commons license in exchange for an Article Publication Charge (APC), upon signing a special Brill Open Consent to Publish form.
