## Rural History

Contributors should submit two copies of articles, typed double-spaced on A4 paper, with reasonable margins. Articles should normally be no more than 8,000 words, but longer articles will be considered. An Abstract of about 150 words should also be supplied.

Disk Submission. Contributors of an accepted article are encouraged to provide the article on disk as well as in hard copy. The disk should be Macintosh or IBM compatible and labelled with the word-processing format used.

## Style

Contributors should aim for a style that is accessible to readers in related disciplines. Masculine forms used as universals, e.g. 'the archaeologist and his aspirations', should be avoided. Articles may be in either English or American spelling.

## Citation

Contributors may follow either of the standard conventions:
(a) in-text citation of sources;
(b) citation in footnotes.
(c) In-text citation.

Give author's surname, date of publication and page references (if any) in parentheses in the body of the text, e.g. '(Falassi, 1980b: 114)'. Where a second or subsequent work by a particular author in the same year is cited, references should be distinguished by letters ( $a, b, c$, etc.) placed after the date.

A complete list of references cited, arranged alphabetically by authors' surname, should be typed doublespaced at the end of the article in the form:

Falassi, A. 1980b. Folklore by the Fireside: Text and Context of the Tuscan Veglia (Austin, Texas).
Give place of publication, but not the publisher. Titles of books, articles and journals should be in the form of the examples in these Notes.
(b) Citation in footnotes. References should be given in notes, numbered consecutively through the typescript with raised numbers. Type the notes double-spaced on separate pages at the end of the article.

Full publication details should be given at first mention, a short form thereafter.

## Books:

Capitalize the principal words and underline the title. Give place and date of publication. Page references should be preceded by 'p.' or 'pp.' Use 'ed.', 'eds.'.

## Short form:

Articles: Capitalize only the first word and proper names in article titles, which should be in single inverted commas. Underline the title of the journal. Use arabic numerals for volume numbers. Do not use 'p.' or 'pp.' with a preceding volume number.

## Quotations

Quotations should be in single inverted commas, with double used only for quotations within quotations. Quotations of more than about five lines should be set off from the text and indented. Type doublespaced.

## Abbreviations and Latin conventions

Cf. Use to mean 'compare', not 'see'.
Ibid. Use to refer to an immediately preceding citation. Do not use loc. cit. or op. cit.
et. al. Use for second and subsequent citations of works by three or more authors. Note: f., ff. (with full point), n.d. (when no publication date), passim.

## Tables and illustrations

Tables, graphs, maps and line drawings should be provided on separate sheets.
Tables. Tables must be numbered consecutively and referred to in the text as such: '(see Table 1)', not ('see table below)'. The table number and table title should be typed above the table. Type horizontal rules above and below the body of the table and below column headings, but avoid vertical rules. Notes and source(s) should be typed below the bottom rule.

Illustrations. We welcome illustrations as accompaniments to articles, but it is the responsibility of contributors to provide illustrations in a form suitable for direct reproduction, unless otherwise agreed with an editor. Photographs (black and white glossy prints) and line drawings must fit the text area of 200 x 135 mm , and originals submitted should ideally be no more than one and a half times that size.

Number (in light pencil) and identify illustrations on the reverse, in order. Mark the number in the margin of the text at the approximate position where the illustration should appear, e.g. 'Figure 1 near here'. Captions should be typed double-spaced on a separate sheet.

Permissions. Contributors should provide full details of the illustration source and obtain permission to reproduce copyright material. Any necessary acknowledgement should be included in the caption.

## Proofs

Contributors will receive a proof of their article for correction of any printer's errors and any essential factual errors.

## Offprints

Twenty-five offprints of each contribution will be supplied, to be sent to the first named author in the case of jointly authored contributions. Further offprints may be purchased if ordered at first proof stage.

## Copyright

Authors of articles published in the journal assign copyright to Cambridge University Press (with certain rights reserved) and you will receive a copyright assignment form for signature on acceptance of your paper.

In assigning your copyright, you are not forfeiting your right to use your contribution elsewhere. This you may do without seeking permission, and subject only to normal acknowledgement to the journal.
