

## Instructions to Authors

**Submission of Manuscripts.** Manuscripts must be submitted in complete form, with illustrations (if any), legends to illustrations and an abstract. An AMS subject classification (primary, secondary) and suitable keywords and phrases should be given on the title page. The text should be concise; in general, manuscripts should not exceed 20 standard pages. The number of illustrations should be kept to the minimum required for clarification of the text. (Colored illustrations can be printed only at the cost of the author.) Illustrations, tables, equations, and footnotes should be numbered consecutively throughout the article.

References, numbered consecutively with square brackets, should be grouped together

at the end of the paper and should specify the following:

- a) Books: name of author, title, volume and edition, page, place of publication, publisher, year of publication, e. g.:  
Hackbusch, W.: Iterative solution of large sparse systems of equations. New York: Springer 1993.
- b) Journals: name of author and title of article, abbreviated title of journal, volume, page, year, e.g.:  
Burkard, R. E., He, Y.: A note on MULTIFIT scheduling for uniform machines. Computing 61, 277-283(1998).

**Use of Electronically Readable Material.** To facilitate and accelerate editorial handling as well as the production of the journal, authors should attempt to adhere to the following instructions. Authors who are not able to provide the specified electronically readable versions of their manuscripts may submit only printouts, however, both editorial handling and publication of the accepted manuscript may thus be delayed to some extent.

- a) Submission of manuscript: A submission should consist of two parts:
  - One complete printed copy of the manuscript, marked as a submission for Computing, sent by Priority mail. The accompanying letter must contain the (corresponding) author's full postal address and his e-mail address.
  - A postscript file of the manuscript, sent by e-mail with subject "submission for Computing". The file must print on European (A4) and US standard paper format.

Both the paper copy and the postscript file should be sent to someone in the Editorial Board who is likely to have expertise in the area of the submission.

b) Submission of the accepted manuscript:

After a manuscript has been accepted for publication in Computing by the editor who has supervised the editorial procedure (responsible editor), the following must be sent to the managing editor, Professor W. Hackbusch:

A LaTeX file of the *complete and exact* content of the final version of the manuscript (except, possibly, the figures, see below); this file will be used as *textual source* for the conversion of the manuscript to the Computing style while the *layout* of the printed article will be guided by the appearance of the author's hardcopy manuscript and the requirements of the journal. This file must satisfy the following specifications:

It has been written in standard LaTeX 2.09 or LaTeX 2e under

\documentstyle(class)[12pt]{article}.
```

No stylefiles have been used. The following standard packages may be used:

amsmath, amsfontr, amssymb, latexsym.  
No personal (re)definitions (macros) have been used for features available in standard LaTeX. Other macros should be used only when absolutely necessary.

Figures which are not described in standard LaTeX may be submitted in the form of *encapsulated postscript files* using the eps-format. Additionally, enlarged and well-reproducible hard copies of figures (high-contrast laser printouts with inscriptions in sans-serif types not smaller than 10 pt, in order to remain legible after necessary reduction to the maximum journal format width of 12.2 cm) must be submitted by postal mail.

Except for ps-files of figures, there must not be any other separate input or accessory files. The submitted LaTeX file must run under a standard LaTeX compiler and produce the

complete manuscript except, possibly, for some or all of the figures of which only the legends are retained.

**Proofs, Offprints.** For all papers page proofs will be sent as PDF files to the authors. Misprints only should be corrected, and no changes of contents or style should be made on the page proofs. Costs caused by changes or revisions in the page proofs - other than those resulting from printer's errors - exceeding 10 per cent of the typesetting costs will be charged to the author. Springer will supply the corresponding author with 50 offprints of each paper free of charge. Additional offprints may be ordered at cost price. A price list and an order form will be sent with the proofs. The filled-in order form should accompany the corrected proofs when they are returned.

**Online First Publication.** *Online First* articles are published in electronic form weeks before distribution of the printed journal. An *Online First* publication date is published in each *Online First* article and its print version. Authors should be aware that after electronic publication they cannot withdraw an article or change its content. Any corrections have to be made in an Erratum which will be hyperlinked to the article. *Online First* articles can be cited using their *Digital Object Identifier (DOI)*, a unique and consistent identification code included in both the print and the electronic versions.
