Title of article cannot exceed 120 characters with spaces and cannot include abbreviations

Include institution(s) and department(s) where study was performed

Include all grant support information Include name, address, business telephone number, fax number and e-mail address for corresponding author

#### Abstract

Cannot exceed 250 words
Abbreviations must be spelled out
Include Background & Aims, Methods, Results and
Conclusions (in that order)

#### Article Proper

Manuscript should not exceed 21 double-spaced pages including references, tables and figures; for electronic submissions, include title page and abstract with body of manuscript

#### Figures

Resolution must be at least 72 dpi
Figures that are submitted and reviewed in color must be
published in color upon acceptance
Author is responsible for color reproduction costs
Fax written agreement for color reproduction costs to (301)
