Authors wishing to have papers published in the Journal should send them to any editor; the submission of four copies will expedite assessment. Original drawings should not be sent until the paper is accepted. The initial submission will be acknowledged by post or e-mail but not subsequent communications.

Submission of a paper implies a declaration by the author that the work is not being considered for publication elsewhere and that it has not already been considered by a different editor of the Journal. A report on a conference must be submitted within three months of the meeting.

In a case of serious disagreement between the author and an editor concerning the merits of a submitted paper, the author may appeal for an independent assessment of the paper. The Editor acting as Arbiter will conduct the assessment.

There is no charge for publication, although the cost of any colour figures (£500 per page) must be borne by authors.

Preparation of papers

Authors are urged to write their papers clearly and attractively, so that their work will be readily understood by readers. A brief [summary](#) of editorial style and notation is available. Manuscripts should be typed in *double spacing* on one side of the paper only, with references listed at the end in alphabetical order of authors and with a separate list of figure captions. Figures should be high quality, and dot fills should be kept to 100 lines per inch or lower to avoid interference problems on scanning and reduction. Lettering will be inserted by the printer and should be shown clearly on copies of the figures, together with the relevant captions, rather than on the originals where possible. Extensive detailed mathematical relations, tables or figures likely to be useful only to a few specialists are usually not printed but instead are held in the editorial files, with copies being made available to readers on request.

Electronic submission of papers (in finally accepted form only)

Papers accepted for publication in the Journal can be printed directly from author-prepared electronic files in LaTeX using a JFM style macro, and authors are strongly encouraged to use this option. The initial submission for review must be in hard copy form, double-spaced using the [referee] option (see [jfmguide.tex](#)).

The LaTeX 2.09 style file `jfm.sty` together with a guide to its use `jfmguide.tex`, sample pages `jfmsampl.tex` and a guide to editorial style and notation `jfmnot.tex`, or the corresponding LaTeX 2e files `jfm.cls`, `jfm2egui.tex`, `jfm2esam.tex` and `jfm2enot.tex` are available via anonymous ftp from the Cambridge University Press at `ftp.cup.cam.ac.uk` in the directories [/pub/texarchive/journals/latex/jfm-sty](#) or [/pub/texarchive/journals/latex/jfm-cls](#).

A recent addition is a JFM BibTeX style file which can be found, together with sample files `bibsamp.tex` and `bibsamp.bib`, in the directories [/pub/texarchive/journals/latex/jfm-sty/bst](#) for LaTeX 2.09 and [/pub/texarchive/journals/latex/jfm-cls/bst2e](#) for LaTeX 2e.

These files will be updated periodically; please make sure that you have the latest version (v1.32, LaTeX 2.09; v1.21, LaTeX 2e - January 1998). While use of the JFM LaTeX style file is preferred, ordinary LaTeX or plain TeX files can also be accepted.

Note that papers must be suitably prepared, adhering closely to JFM editorial requirements for notation, English and presentation, a [summary](#) of which is available. Any editorial changes will be made by the printer and if these are numerous it may be more efficient to set the paper conventionally.

When the paper has been accepted for publication, and only then, the TeX file on a diskette, together with an identical hard copy and the figures, should be sent to the Editor handling the paper. The file can, alternatively, be sent by email to the Editorial Assistant at jfm@damtp.cam.ac.uk.

Electronic files for the figures are not required: good quality hard copies should be provided for scanning. However, if it is difficult to obtain a good quality hard copy it may be possible to print directly from a TIFF format file.

An author is entitled to 50 offprints of the published paper free of charge, and additional offprints can be purchased if ordered by completing the form sent out with the proofs. If no order form is received, the free offprints will be sent to the first author at the address given on the title page of the paper. Since offprints are printed at the same time as the paper itself, it is not possible to order additional copies once the paper has gone to press.
