

Instructions for authors

Submission of a manuscript implies: that the work described has not been published before (except in the form of an abstract or as part of a published lecture, review, or thesis); that it is not under consideration for publication anywhere else; that its publication has been approved by all co-authors, if any, as well as by the responsible authorities – tacitly or explicitly – at the institute where the work has been carried out. The author(s) transfer(s) the copyright to his/her article to Springer-Verlag effective if and when the article is accepted for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable.

The author(s) guarantee(s) that the manuscript will not be published elsewhere in any other language without the consent of the copyright holders.

The work of the editors and the publisher will be greatly facilitated if the following suggestions are adhered to:

Manuscripts must be accompanied by the "Copyright Transfer Statement." The form is regularly published in the printed journal or can be obtained from <http://link.springer.de>.

Manuscripts must be in English and submitted to the editor who is **geographically nearest** to the corresponding author. Authors who are in doubt about where to submit a manuscript should contact the Editor-in-Chief or one of the Editors. The final decision on manuscript acceptance rests with the Editor-in-Chief. The date of final manuscript acceptance and the name of the communicating editor precede each printed contribution. One original manuscript typed on one side of the sheet only, plus 3 copies photocopied on both sides to keep postage charges at a minimum, and illustrations should be submitted. In order to reduce mailing costs, rejected manuscripts will only be returned to the authors when they contain important original comments from the referees. Original illustrations will always be returned.

Electronic data should not be submitted until a paper has been reviewed and accepted.

The text must be carefully considered, since changes at the proof stage are limited to correction of printing errors. Please use the metric system and the standardized gene nomenclature for protein-coding (Trans. Am. Fish. Soc. 119: 2–15, 1990). Special or unusual symbols must be explained in the margin.

Please include at the end of the acknowledgements a declaration that the experiments comply with the current laws of the country in which the experiments were performed.

Three manuscript pages typed in double-line spacing (35 lines of 60 strokes) equal one printed page. **The maximum number of printed pages permitted is twelve.**

Authors who have written their manuscript using a PC word processor are asked to submit the files following the technical instructions for the preparation and submission of manuscripts in electronic form printed in each issue of the journal or available from <http://link.springer.de>. Springer offers a user-friendly **Word document template** for writing your manuscript. For further details of this template and for information on compiling a manuscript, consult the technical instructions.

The text should be presented in clear, short sentences and preferably arranged as follows:

Title of paper, author's name, institution; city, country. To facilitate communication between the authors, editors and publisher, the author should furnish a fax number and e-mail address on the title page of the manuscript.

Abstract: Abstracts should briefly describe problems, results and conclusions.

Introduction

Materials and methods

Results

Discussion and conclusions

Acknowledgements (if applicable)

References This list must include all (but no additional) references quoted.

Examples for citations of literature:

In the text:

Jones (1987) or (Jones 1987 a, b), etc. Two authors are to be cited as: Jones and Smith (1987), more than two authors, Jones et al. (1986). Arrange names of authors **chronologically in text**, e.g. (Jones 1986; Allen 1987)

Under 'References':

Papers with two authors should be arranged alphabetically by second author, in preference to chronological order, e.g.:

Hatch MJ, Macek K (1986)
Hatch MJ, Smith HB (1985)

Papers by more than two authors (et al.) should be listed chronologically.

a) Periodicals. Sequence of citation: author's name, initials, year of publication, full title of paper, periodical (abbreviated in accordance with the Bibliographic Guide), volume, first and last page nos.

Example:

Fisher CR, Childress JJ (1986) Translocation of fixed carbon from symbiotic bacteria to host tissues in the gutless bivalve *Solemya reidi*. Mar Biol 93: 59–68

b) Books. Sequence of citation: author's or editor's last name, initials, year of publication, full title, publisher, place of publication.

Examples:

Kirk JTO (1983) Light and photosynthesis in aquatic ecosystems. Cambridge University Press, Cambridge.

White HH (ed) (1984) Concepts in marine pollution measurements. Maryland Sea Grant College, University of Maryland, College Park

c) Composite works or serials. Sequence of citation as above, but full title of paper followed by In: editor(s) if any, full title of publication, etc. as above, followed by first and last page nos.

Example:

Fenchel T (1987) Ecology – potentials and limitations. In: Kinne O (ed) Excellence in ecology, Bk. I. Ecology Institute, Oldendorf/Luhe, pp 1–186

Full publication details must be given for any citation not fitting into the above categories, and also for any publication recently issued for the first time.

Electronic Supplementary Material. Data such as black and white or colour illustrations, large tables, animations, video clips or sound recordings that are not essential to the understanding of a printed article but of relevance to it can be made available on Springer-Verlag's server. Access will be free of charge from the contents site of this journal. Such material must be submitted in electronic form (see special

instructions published regularly in the printed journal or the electronic version on <http://link.springer.de>) as well as nonelectronic form for reviewing purposes. Supplementary material will be referenced in the printed article.

Figures must be numbered, and should be submitted (in triplicate) as originals, ready for reproduction. Line drawings and half-tone illustrations should be up to 8.6 cm in width to fit one column and up to 17.8 cm in width to fit two columns. When the desired size has not been specifically stated, the publisher reserves the right to reduce or enlarge the illustrations.

For color illustrations the authors will be expected to make a contribution (€ 485.00 or US \$ 475.00, plus 16% VAT) towards the extra costs, irrespective of the number of color figures.

For **line drawings**, ink drawings or good-quality prints thereof in the desired final size, are preferred. Computer drawings are acceptable provided they are of comparable quality to line drawings. Lines and curves must be smooth. The lettering should be clearly legible. Letters 2.00 mm high are recommended.

For **half-tone illustrations**, well-contrasted photographic prints, trimmed at right angles and in the desired final size are required. Lettering should be about 3 mm high.

Each figure must have a short, precise legend. Legends should be listed on a sheet of paper following the list of references.

If plates are submitted, the figures must be mounted on regular bound paper, not on cardboard.

Submission of digital images can mean more efficient production. The files should be compiled in accordance with the technical instructions for digital images (<http://link.springer.de>).

Tables must be numbered and be headed by brief legends.

For both figures and tables, the desired placement must be marked in the text margins. Where applicable, each figure and each table should be preceded by the genus and species name of the organism referred to. All symbols or abbreviations used must be briefly explained in the legends or as footnotes to the tables. Please mark table footnotes as a, b, c, etc.

Italics Please italicize genus and species names.

Proofs Authors should make their proof corrections on a printout of the pdf file supplied, checking that the text is complete and that all figures and tables are included. After online publication, further changes can only be made in the form of an Erratum, which will be hyperlinked to the article.

Offprints Offprints may be ordered at cost price when the page proofs are returned. Springer will supply the corresponding author with one free copy of the relevant issue.
