3 Manuscript preparation

To allow speedy publication manuscripts should be prepared carefully in accordance with the following points:

All manuscripts are subject to copy editing.

Title page

- A concise and informative title
- The name(s) of the author(s)

- The affiliation(s) and address(es) of the author(s)
- The e-mail address, telephone and fax numbers of the communicating author

An **abstract** of preferably not more than 250 words should precede the main text. The abstract should be structured with the subheadings Objective, Methods, Results, Conclusion. Letters to the Editor or Case reports should not contain an abstract.

Abbreviations should be defined at first mention in the abstract and again in the main body of the text and used consistently thereafter. Abbreviations and units should conform to the Internationals System of Units (SI).

Footnotes to the text should be numbered consecutively and placed at the bottom of the page to which they refer.

References

The list of References should only include works that are cited in the text and that have been published or accepted for publication. Personal communications should only be mentioned in the text.

Journal titles should be abbreviated according to *Index Medicus*.

Citations in the text should be identified by *numbers in square brackets*, and the list of references at the end of the paper should be both *alphabetized* under the first author's name and numbered.

References by the same author or team of authors should be listed in chronological order.

References with correct punctuation should be styled as follows:

If available the **Digital Object Identifier (DOI)** of the cited literature should be added at the end of the reference in question.

Illustrations and Tables

All figures (photographs, graphs and diagrams) and tables should be cited in the text, and each numbered consecutively throughout. Lowercase letters (a, b etc.) should be used to identify figure parts. If illustrations are supplied with uppercase labeling, lowercase letters will still be used in the figure legends and citations.

Half-tone illustrations (black and white color). Magnification should be indicated by *scale bars*. Details that might identify patients should be omitted unless absolutely necessary for

scientific reasons. Falsification or altering of data should never be used as a means of ensuring anonymity; masking of the eye region in photographs of patients may be inadequate. If identification of patients is unavoidable, the author must guarantee that the reproduction of illustrations in which a patient is recognizable is approved either by the patient him-/herself or by his/her legal representative.

Figure legends must be brief, self-sufficient explanations of the illustrations. The legends should be placed at the end of the text.

Tables should have a title and a legend explaining any abbreviation used in that table. Footnotes to tables be indicated by superscript lower-case letters (or asterisks for significance values and other statistical data).

For **color illustrations** the authors will be expected to make a contribution towards the extra costs (€ 485.00, US\$ 435.00, plus 16% VAT), irrespective of the number of color figures.

4 Electronic supplementary material

Electronic supplementary material (ESM) for an article in the journal will be published in Springer Link provided the material is

- submitted to the Editor(s) in electronic form together with the paper and is subject to peer review
- accepted by the journals Editor(s)

ESM may consist of

- information that cannot be printed animations, video clips, sound recordings
- information that is more convenient in electronic form: sequences, spectral data, etc.
- large original data that relate to the paper, e.g. additional tables, illustrations (color and black & white) etc.

After acceptance by the journals Editor(s) ESM will be published as received from the author in the online version only. Reference will be given in the printed version.

5 Proof Reading

Authors should make their proof corrections on a printout of the pdf file supplied, checking that the text is complete and that all figures and tables are included. After online publication, further changes can only be made in form of an Erratum, which will be hyperlinked to the article.

6 Off Prints

Two (2) complimentary copies are supplied. Orders for offprints can be placed by returning the order form with the corrected proofs. When you order offprints, you are entitled to receive in addition a pdf file of your article for your own personal use.

The copyright to this article is transferred to Springer (respective to owner if other than Springer and for U.S. government employees: to the extent transferable) effective if and when the article is accepted for publication.
