Manuscript submission

Polymer Bulletin provides rapid publication of significant advances in polymer science, including chemistry, physical chemistry, physics and material science. Manuscripts must be in English and must not exceed eight pages. All papers will be reviewed by at least two referees.

They are to be sent in electronic form as well as a printout to the responsible regional editor **for Europe and Africa**

Manuscript preparation The author(s) transfer(s) the **copyright** to his/their article to Springer-Verlag effective if and when the article is accept-ed for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable.

In order to assure rapid publication, papers in this journal are reproduced from camera-ready copy, therefore it is essential that

- they are prepared using our [templates](#) for Polymer Bulletin. You can download them from <http://www.springer.de/chem/authors/index.html>
- we must have a fast communication between authors, editors, and the publisher; authors are requested to provide fax, e-mail and telephone numbers.
- the reviewing process is speeded up to 2-3 weeks maximum; we will use the authors' electronic form of manuscripts in order to minimize the mailing time.

1. If you use our **templates**, it will be much easier for you to prepare your manuscripts. Just follow the instructions accompanying the Polymer Bulletin template. The buttons in the word toolbars (for the title page, the text, the figures and tables) are arranged in the order you should use them. You also can use the template with a document you have already created.

3. **Figures.** Line drawings may be imported directly into the word template. Figure parts should be identified by lower case roman letters. Simple square graphs can often be presented side by side or with the legend beside the graphics using the two-column button. Second or subsequent lines of figure legend should not be intended.

4. **Halftone illustrations** must be submitted separately and have to be marked on the back side with the main author's name and the Fig. No. Usually the printing company has much better equipment to scan them than the authors. In the template the appropriate space has to be left free.

5. **Color illustrations.** When color illustrations are sub-mitted a note must be attached indicating whether they are to be reproduced in color and, if so, to whom the invoice for the extra costs involved should be sent. For color illustrations the authors will be expected to make a contribution (€ 485 or US \$ 345, plus 16% VAT per article) towards the extra costs.

6. **References** should be cited in the text by numbers enclosed in parentheses: [1], [2] etc. (using the [] button makes it easier for you). In the Reference section, the papers appear in numerical order of citation. No blank lines should be left between references. The structure of the entries should be based on the following examples:

7. **Offprints.** Authors receive 30 free offprints per paper. An offprint order form for additional offprints and for a pdf-file of your contribution will be sent to authors upon acceptance of a manuscript. This form must be returned promptly to Springer-Verlag, Heidelberg, to ensure receipt of the offprints and to avoid additional expense after publication of the issue.

8. **Online edition.** Your paper will be made available electronically via Springer-Verlag's online journal service SpringerLink in pdf format.
