The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable.

Manuscripts must be accompanied by the "Copyright Transfer Statement" (the form is regularly published in this journal).

Manuscript preparation. Original, unpublished manuscripts (English language only) should be submitted in accordance with the following rules:

- Address your manuscript to the Editorial Office (Managing Editor).
- Identify the corresponding author if the first author of the paper is not the one to whom correspondence should be addressed.
- *The title, name(s) of author(s) and complete mailing address including telephone, fax numbers and e-mail address* (if possible), as well as the relevant *key words* should appear on the first page.
- Classify your manuscript according to the following categories: *Original paper, Review article, Short communication, Letter to the Editor, Commentary, Controversial issue* (for details see below).
- Submit one original and one copy version, including one camera-ready set and one set of photocopies of all tables, figures and other artwork.
- Submit original manuscripts single-sided and double-spaced with pages numbered consecutively, and with all margins at least 25 mm.
- Submission of manuscripts on *diskette* implies a considerable shortening of the publication period and is very welcome. However, authors are requested to await the completed refereeing procedure and to send only the revised and final manuscript text files. Please follow the respective *Technical instructions* printed in each issue of the journal.
- A separate list of figure captions and footnotes should follow the reference section.
- Please be sure that figure legends and text agree, that the same terms, numbers, etc. are used, and that figure and table lettering and data points are in the right size to survive reduction in print. Consider the proportions of the printed page in designing the illustrations.
- Prepare your manuscript according to the *style requirements* below.

Style requirements. Manuscripts should be carefully checked before submission to exclude the need for later corrections, since authors will receive only one set of proofs. Manuscripts must be submitted in their final form. Any subsequent alterations to the text are time-consuming and expensive.

- Please include an *Abstract* – a single concise paragraph – with *Original papers, Review articles* and *Short communications*.
- Include the appropriate *section headings* in the following order and without numbering them: *Introduction, Materials and methods (General considerations), Results, Discussion, Conclusions, Acknowledgements, References*.
- Use the *International System of Units (SI)*.
- Use *standard abbreviations* and provide a key, if it is necessary to use unusual abbreviations.
- Keep *footnotes* to a minimum and mark them with asterisks or other superscript footnote symbols throughout the text.
- Indent all paragraphs but the first.
- Avoid end-of-line hyphenations to prevent typesetting confusion.
- Capitalize and spell out 'Table', but abbreviate 'Figure' and 'Equation' (e.g. Fig. 1; Eq. (1)) in the text and in captions.

Tables

- Submit one set of good-quality original tables and one photocopied set.
- Put an appropriate caption above each table and number them in sequence with arabic numerals.
- Provide each table on a separate page and label it on the back with the first author's last name.
- Do not imbed tables in text, but mark their approximate position in the margin.

Figures/Artwork

- Submit one clear, high-quality, camera-ready version of each figure and one photocopied set.
- Submit line drawings of adequate quality for reproduction, with letterings and symbols in appropriate size and with high contrast. Reduced glossy prints of original line drawings or high-resolution computer graphics are acceptable.
- Figure ports should be identified by lower-case roman letters.
- Include a separate list with figure captions.
- Provide each figure on a separate page and label it on the back consecutively with arabic numbers and the first author's last name.
- Do not imbed figures in text, but mark their approximate position in the margin.
- For color illustrations the authors will be expected to make a contribution (EUR 485.00 or US \$ 435.00 (plus 16% VAT) per article) towards the extra costs.
- Illustrations prepared in digital form must be in accordance with the *special instructions* that are published in this journal.

References

- The list of references should be provided on a separate page, numbered in order of citation.
- References should be limited to material that is accessible. Where *reports, private communications, dissertations*, etc. need to be cited, adequate information as to their source and availability must be given.
- References should be relevant and not unnecessarily numerous.

- All references should be cited in the text by arabic numerals in brackets corresponding to the numbered list of references.

- Note the following examples for references in *Radiation and Environmental Biophysics* format:

Electronic Supplementary Material. Data such as black and white or colour illustrations, large tables, animations, video clips, or sound recordings, that are not essential for the understanding of a printed article but yet of interest can be put on Springer-Verlag's server and will be accessible free of charge on the contents site of this journal. Such material has to be submitted in electronic form (see the special instructions that are regularly published in this journal) and will also be reviewed. Reference to this material will be given with the printed article.

Proofs. The corresponding author will receive one set of proofs, together with an offprint order form and an offprint price list. Offprints can be purchased at cost price, providing the order is returned together with the proofs.

Manuscript categories. *Short communications* are brief reports including discussion of current problems, contributions of didactic nature or general significance, and additional observations.

The Editors may invite or consider submissions that deal with subjects of interest and that do not fit other categories of manuscripts. This type of communication is a *Commentary* or a *Controversial issue*. A *Letter to the Editor* is of similar nature.

Please include at the end of the acknowledgements a declaration that the experiments comply with the current laws of the country in which the experiments were performed.

The Editor-in-Chief reserves the right to reject manuscripts that do not comply with the above-mentioned requirements. The author(s) will be held responsible for false statement or for failure to fulfil the above-mentioned requirements.

In order to reduce mailing costs to a minimum, rejected manuscripts will not be returned (except for the original figures and artwork).
