INFORMATION FOR AUTHORS

Where desired, arrangements can be made for Adis International to provide technical editorial assistance in preparing a final manuscript from research findings (for further information, contact the Editor).

Manuscript Preparation: Articles are accepted in English only. To facilitate rapid publication, wherever possible the manuscript should be submitted in Journal style (see below). Please submit an original plus one copy, typed double-spaced on one side of A4 (or nearest equivalent) paper using wide margins. Manuscripts should be submitted on a computer diskette where possible. Our preferred word processor is WordPerfect 5.1, but we can also accept other packages. The diskette must be accompanied by full details of the hardware, operating system and software (including version number) used to prepare the manuscript.

Tabular material should be prepared using the 'Tab' key rather than word spaces, and tables should preferably be created in WordPerfect table format. In any case, an ASCII file of the text, tables and references with the filetype .TXT (i.e. filename.TXT) should also be included on the diskette.

Title Page: There should be a separate title page with title, authors and institutions where the work was done, indicating the city, and a condensed running title of not more than 50 characters including spaces. Acknowledgements and the name and postal address, plus fax and e-mail numbers (if available), of the author to whom correspondence should be addressed should also be included.

Abstract: The abstract should not exceed 150-250 words. It should be factual, not descriptive, and should present the reason for the study, main findings (giving specific data if possible), and principal conclusions. As such, the abstract should be structured under the following headings:

objective, design, setting, patients or study participants, interventions, main outcome measures and results, conclusions.

Methods/Results/Discussion/Conclusions: Description of the experimental results should be succinct, but of sufficient detail to allow the study to be repeated by others. Conclusions and theoretical considerations must not appear in the results section, nor is a recapitulation of the results acceptable for the discussion section. Where relevant, a concise statement of the clinical implications of the study results should appear at the end of the conclusions.

Short Communications and Case Reports: The length of Short Communications and Case Reports should not exceed 1800 words, and figures and tables should be limited to one each if possible.

Correspondence: Letters to the Editor will be considered for publication. Commentaries on articles published in the Journal will be submitted to the original authors of the article for comment and right of reply. Letters will be reviewed by an Adis editorial review panel for relevance, suitability and timeliness, and may be edited prior to publication. Correspondence should not exceed 300 to 500 words.

Reference Style: References are required to support all significant statements. They are also used to indicate the origin of material (quotations, tables, figures), and as a source for research and further reading. They need to be given in a form where the reader can quickly and easily identify the correct reference and locate the material in a library or on a database.

Our referencing system is based on the 'Uniform Requirements for Manuscripts Submitted to Biomedical Journals' (the 'Vancouver' style), with some minor modifications. It is important to adhere to the style set out here (e.g. superior numbers inside square brackets in the text), which will facilitate processing.

Reference Management Software: Good reference management software is available for most computer systems, which makes the task of preparing references much easier. For articles prepared using these applications, a file with the software database containing the raw references should be submitted together with the text output file. The preferred software package is PAPYRUS™ (version 7.0 or later).

Citations in Text: Number references consecutively in the order in which they are first mentioned in the text. Identify references in text, tables and legends by superscript arabic numerals in square brackets. References cited only in tables or in legends to figures should be numbered as if they appear in the text at the first mention of the particular table or illustration.

Information for Authors

Note: These examples are chosen to illustrate particular points that may arise occasionally. In general, it is not necessary to mention the authors' names in the text in the Vancouver system (including in tables). The only reason to do so is if you *specifically* wish to draw the reader's attention to the authors involved (a rare situation) – for example, in relation to a controversial issue where there are groups of authors whose views are well known to be polarised.

Include among the references papers accepted but not yet published; give the journal and add 'In press' in the reference list (see example 40). Try to avoid using abstracts as references. 'Unpublished observations' (i.e. your own unpublished work) and 'personal communications' (i.e. the unpublished work of others) may not be used as references, although they may be inserted (in parentheses) in the text. If you cite a 'personal communication' you should provide evidence that the person(s) quoted has given permission for the use of the material. Information from manuscripts submitted but not yet accepted should be cited in the text as 'unpublished observations' (in parentheses).

Reference List: List references in numerical order.

- · Only the first three authors' names are given.
- Titles of journals should be abbreviated according to the style used in *Index Medicus*. Please consult the *List of Journals Indexed in Index Medicus*, published annually both separately and as a list in the January issue of *Index Medicus*.
- Spellings in references should appear as in the original publication; accents in the original should be followed.
- Where city names (location of conferences and place of publication) are little known or might be confused, the zip code state abbreviation or country name may be added for clarification.

Authors should verify their reference citations against the original documents. Please use the style illustrated in the following examples.

List all authors, but if the number exceeds three, give the first three followed by 'et al.'. Where readily available, provide the month/date of publication.

Illustrations: Legends should make the illustration understandable independently of the text. The approximate position of each illustration should be marked in the text.

Computer-Generated Illustrations: Figures should be prepared using a computer drawing program where possible. *Adobe Illustrator* or *Harvard Graphics (HG3)* are preferred, but other formats can be accepted (.TIF, .PCX, .CGM, .WMF, .WPG and Postscript, and graphs from *Lotus, Excel* and *dBase*). Each figure should be saved as a separate file and accompanied by a high-quality print-out.

Non-Electronic Preparation: Traditionally prepared artwork should be professionally drawn and photographed. Photos and colour pictures should be submitted as transparencies or well contrasted photographic prints trimmed at right angles. Symbols, abbreviations and spelling should be consistent with the text. Lettering and symbols on figures should be clear and legible. The author's name, the figure number and top of the figure must be indicated (lightly) on the back of each print.

Permissions: Should you wish to reproduce previously published figures, please provide the permission request(s) and approval(s) from both the author(s) and publisher(s). If

a figure is extracted from a published source, the full reference must be stated.

Abbreviations and Symbols: Use SI symbols and recognised abbreviations for units of measurement. The first time an uncommon abbreviation appears, it should be preceded by the full name for which it stands, followed by the abbreviation in parentheses. Generally, abbreviations should be avoided as much as possible, and used only when the full term would make the text unduly cumbersome.

Drug Names: Generic (INN) names should always be used (with BAN/USP names enclosed in parentheses), but if not appropriate (e.g. a product with several components) brand names (e.g. 'Name') can be used. In original research articles, the manufacturer of the drug must be given.

Address for Correspondence: The name, address and telefax number (if available) of the author to whom correspondence should be addressed should appear on the title page. Review Action: Manuscripts are examined by the editorial staff and referees. Authors of submitted articles will be notified of the acceptability of a manuscript within 4 to 6 weeks.

Reprints: Authors will be provided with 30 offprints free of charge. Bound reprints can be provided at the appropriate scale of charges current at the time of publication.
