

Legal and editorial requirements

The author(s) transfer(s) the copyright to his/their article to Springer-Verlag effective if and when the article is accepted for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable.

Manuscripts must be accompanied by the "Copyright Transfer Statement" (the form is published in this journal or can be printed out online; see complete list of journals at <http://link.springer.de> or link.springer-ny.com).

All papers submitted for publication should conform to the "Uniform Requirements for Manuscripts Submitted to Biomedical Journals" that has been published by the International Committee of Medical Journal Editors [Br Med J (1991) 302:338–341 & N Engl J Med (1991) 324:424–428]; see also JAMA 277(11):927–934.

Reports of animal experiments must state that the "Principles of laboratory animal care" (NIH publication No. 85-23, revised 1985) were followed, as well as specific national laws (e.g. the current version of the German Law on the Protection of Animals) where applicable.

The Editor-in-chief reserves the right to reject manuscripts that do not comply with the above-mentioned requirements. The editors cannot enter into correspondence about papers that are rejected as being unsuitable for publication, and their decision is final. The author will be held responsible for false statements or for failure to fulfil the above-mentioned requirements.

All papers should be based on present-day standards and relate to occupational or ambient environmental problems (see aims and scope text on inside cover page). Papers are to be written in standard grammatical **English**; this is the responsibility of the author. Although either British or American usage is permitted, the usage in each paper must be consistent.

Manuscripts submitted for publication must contain a statement to the effect that all human studies have been reviewed by the appropriate ethics committee and have therefore been performed in accordance with the ethical standards laid down in an appropriate version of the 1964 Declaration of Helsinki. It should also be stated clearly in the text that all persons gave their informed consent prior to their inclusion in the study. Details that might disclose the identity of the subjects under study should be omitted.

Short communications will be given priority.

Manuscript preparation

1. Please submit one original manuscript typed on one side of the paper only plus two copies photocopied on both sides to keep postage charges to a minimum. In order to reduce mailing costs, rejected manuscripts will not normally be returned, except for original illustrations.

Submission of diskette. Upon notification of acceptance, authors are requested to submit a diskette containing the final version of the manuscript. Springer offers a user-friendly Word document template for writing your manuscripts. Please consult the Technical instructions for manuscripts

and illustrations in electronic form published regularly in this journal. Please do not transmit any data to the publisher until your manuscript has been reviewed and accepted for publication.

Manuscripts must be typed in double-line spacing, with wide margins, and on one side of the paper only. Placement of the figures and tables should be indicated in the left margin. The journal requirements regarding form and style of presentation must be observed. For this reason, it is important to look through a recent copy of the journal before preparing a manuscript. Form and content must be carefully checked to exclude the need for correction in proof, as a charge will be made any changes introduced after the manuscript has been set in type.

A statement to the effect that essential results have not been and will not be published elsewhere must accompany each manuscript.

2. The **title page** should contain:

- The names of the authors.
- The title of the paper. (For bibliographic reasons, double titles are undesirable.)
- The names of the authors together with their respective affiliations. Addresses should be complete and may be given in the local language. An envelope symbol should be used to indicate the author to whom correspondence should be sent.
- The fax and e-mail numbers of the corresponding author.

3. **Abstract.** Each paper must be preceded by a structured abstract (Objectives, Methods, Results, Conclusions). Abbreviations must be explained at first mention. The Abstract should **not exceed** 300 words.

4. **Key words.** Immediately following the Abstract no more than 5 key words are to be supplied for subject indexing. They should be taken from *Index medicus* (Medical subject headings) or, failing this, be composed by analogy on the same principle.

5. **Footnotes** to the title of the paper are not given reference symbols; those to the authors are numbered and placed at the bottom of the title page. Footnotes to the text are numbered consecutively; those to tables should be indicated by superscript lower-case letters (or asterisks for significance values and other statistical data).

6. **Acknowledgements.** As an appendix to the text one or more statements should specify (1) contributions that need acknowledging but do not justify authorship; (2) acknowledgements of technical help; (3) acknowledgements of financial and material support; (4) relationships that may pose conflicts of interest, e.g., financial relationships with industry or trade unions.

7. **References.** All references cited in the text, but only those, are to be listed at the end of the paper in alphabetical order under the first author's name. Chronological order is used for more than one work by the same author or team of authors. Works by two authors should also be listed alphabetically according to the second author's name. Journal titles should be abbreviated according to *Index medicus*. When styling references, the following examples should be followed.

Doll R (1991) Weak associations in occupational epidemiology and the criteria for deducing causality. In: Schettler G, Schmähl D, Klenner T (eds) Risk assessment in chemical carcinogenesis. Springer, Berlin Heidelberg New York, pp Source of **CD-ROMs** must be provided in References.

Citations in the text should either be by numerals in square brackets referring to an alphabetically ordered, numbered list, or by author and date in parentheses. Either style is acceptable if used consistently throughout the paper. In the latter system, if there are two authors, both should be named (e.g., Agar and Douglas 1955); if a work with more than two authors is cited, only the first author's name plus "et al." need be given (e.g., Komor et al. 1979); if there is more than one reference by the same author or team of authors in the same year, then a,b,c, etc. should be added to the year both in the text and the list of references.

8. **Units of Measurements** should be according to the International System of Units (SI). Measurements of length, height, weight, and volumes should be reported in the metric system or their decimal multiples. Blood pressures should be given in millimeters of mercury, temperatures in degrees Celsius.

9. **Illustrations** must be restricted to the minimum needed to clarify the text. Previously published illustrations are usually not accepted. All figures, whether photographs, graphs, or diagrams, must be mentioned in the text and marked lightly in soft pencil on the back to indicate the top of the figure, the author's name, and the figure number. All figures are to be numbered consecutively throughout and submitted separately. Figure parts should be identified by lower-case roman letters.

Line drawings. Good-quality glossy prints should be submitted in the desired final size. The inscriptions should be clearly legible. Letters 2 mm high are recommended.

Half-tone illustrations. Well-contrasted photographic prints should be submitted that are trimmed at right angles and in the desired final size. Inscriptions should be about 3 mm high.

Color illustrations will be accepted; however, the authors will be expected to make a contribution (€ 485, US \$ 534, plus 16% VAT per article) towards the extra costs.

Legends must be short and concise. They must be typed on separate pages, Legends should provide a brief, self-sufficient description of each illustration. Information given in the legends should not be repeated in the text and, similarly, the same data should not be presented in both graph and table form.

10. **Excess page charges** may be requested from the authors for papers exceeding 12 printed pages.

11. **Offprints.** Two complimentary copies are supplied. Orders for offprints can be placed by returning the order form with the corrected proof. When you order offprints, you are entitled to receive in addition a pdf file of your article for your own personal use.
