

Instructions to Authors

Copyright. The author(s) transfer(s) the copyright to his/their article to Springer-Verlag effective if and when the article is accepted for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable.

Manuscripts should be submitted in duplicate to the Managing Editor. Original illustrations should be supplied for reproduction as well as one copy.

1. **Manuscripts** should be written in **clear and simple language**. All text must be double spaced. A typical paper is expected to be about 10 pages long, including figures, captions, tables, footnotes, references, and acknowledgements (at a character count of 6600 per page for text-only pages). Form and content should be carefully checked to exclude the need for corrections in proof. A charge will be made for changes introduced after the manuscript has been set in type. The places at which figures and tables are to be inserted should be indicated in the left margin.

Papers must be written in **English**. Authors whose mother tongue is not English are advised to seek the assistance of a native English speaker who is familiar with the topic of the paper. Before a manuscript is prepared, a copy of the journal should be consulted to ensure that the requirements concerning form and style of presentation are observed.

2. **The title page** must contain the title, the complete name(s) of the author(s), the name and full address of the laboratory or institution where the work was done, and the address to which proofs should be sent. If the title requires a footnote, this must also be included on the title page and indicated by an asterisk.

3. **Abstract.** Each paper must start with an Abstract that summarizes its content. It should be possible, from the abstract, for readers to determine whether or not they have an interest in the paper. Abstracts should not exceed 100 words.

4. **Key words.** Immediately following the Abstract no more than 5 key words are to be supplied for subject indexing. They should not simply be taken from the title, but should represent the content of the whole article and be characteristic of the terminology used within the particular field of study.

5. **The Introduction** should be concise and define the scope of the work in relation to other work done in the same field. It should not, as a rule, give an exhaustive review of the literature.

6. **Footnotes**, should be avoided whenever possible. Essential footnotes other than those referring to the title, should be numbered consecutively and placed at the foot of the manuscript page on which they belong (not at the end of paper).

7. **References.** All references cited in the text are to be listed at the end of the paper in alphabetical order under the first author's name. Chronological order is used if there is more than one publication by the same author or team of authors; where the authors' names and the year of publication are not enough to distinguish different papers, letters a, b, c, etc. should be added to the year.

Responsibility for the accuracy of bibliographic references rests entirely with the author. *Citations* in the text should be by authors and year of publication in parentheses. *Example:* (Whitted 1985; Preparata and Shamos 1985; Dew et al. 1985)

8. **Figures** must be restricted to the minimum needed to clarify the text. All figures (photographs or drawings/diagrams) must be mentioned in the text and labeled lightly in soft pencil on the back to show the top of the figure, the authors' names, and the figure number. Figures must be numbered in the same order as they are first referred to in the text. The references to figures should be as follows: Fig. 3, Figs. 4, 5.

Line drawings. Please submit high-quality glossy prints. The inscriptions should be clearly legible and in a size allowing for reduction.

Half-tone illustrations. Please submit sharp, well-contrasted photographic prints, trimmed at right angles.

Permission. Authors wishing to include figures or text passages that have already been published elsewhere are required to obtain permission from the copyright holder(s) and to include evidence that such permission has been granted when submitting their papers. Any material received without such evidence will be assumed to originate from the authors.

9. **Captions** must be concise and appended to the text. They should provide a brief, self-sufficient description of each figure. Information given in the captions should not be repeated in the text. A list of captions should be provided on a separate page.

10. **Offprints.** Offprints can be ordered at cost price when the page proofs are returned. The author will receive two complimentary copies of the issue.

11. **Authors' biographies.** Authors should supply a black and white glossy photograph and a brief biographical summary (double spaced) of between 50 and 100 words, as appropriate.

Papers prepared with T_EX

Authors who prepare their papers with T_EX

are encouraged to ask for Springer-Verlag's T_EX-macropackages, either by e-mail to strasser@springer.de or via the URL:

<http://www.springer.de/author/tex/help-journals.html> or directly via ftp to <ftp://ftp.springer.de> with user id `ftp` or `anonymous`. Please enter your e-mail address as password. The files reside in `/pub/tex/latex/svjour/global`

Authors who wish to submit disks to the editor should do so only after the manuscript has been accepted for publication. They must then **include any macro definitions** they have used together with a printout for reference. It is important to ensure that the text is identical in the hard copy and in the soft copy.

The production time for papers submitted in this form can be reduced considerably. Authors who have written their papers in T_EX but have not, for whatever reasons, used Springer-Verlag's macros should send in a disk and corresponding hard copy.

Springer-Verlag will then decide on a case-by-case basis whether it makes sense economically to work from the T_EX files.
