Submitting manuscripts

Manuscripts are submitted online via the Editorial Manager. The editors of *Techniques in Coloproctology* expect all authors to disclose any commercial associations they have that might give rise to a conflict of interest in connection with the submitted article. **Should you have any problem submitting your manuscript online please contact the Editorial office by email at ucclub@gmail.com or by fax or regular mail.**

Copyright Transfer Statement

The copyright form is regularly published in the journal or may be downloaded from http://www.springer.com/cda/content/document/cda_downloaddocument/CTS_060213.pdf?SGWID=0-0-45-69724-p1142331. It must be signed by all authors, scanned and uploaded on the Editorial Manager as a separate file, you will be required to upload the scanned copyright form before uploading your manuscript file (see also instructions to authors: online submission via Editorial Manager).

Online Submission via Editorial Manager

We are pleased to announce that we have moved to an online system of manuscript tracking called Editorial Manager (<http://www.editorialmanager.com/col/>). Authors are encouraged to submit their articles to *Techniques in Coloproctology ONLINE*. This will allow even quicker and more efficient processing of your manuscript.

SYSTEM REQUIREMENTS

Authors will need the following in order to use Editorial Manager:

1. Netscape 6.x, MS Internet Explorer 6.x, Mozilla 1.0, Safari 1.0 – or newer version
2. Adobe Acrobat Reader browser plug-in
3. Electronic file(s) of their article text
4. Electronic files of their article illustrations (scanned or exported).

AUTHOR ACCOUNTS

Authors entering the journal's Editorial Manager site can either register and create a new account or use an existing one. When you have an existing account, use it for all your submissions and you can track their status on the same page. If you have submitted to *Techniques in Coloproctology* before, please hit the "check for existing account" button. You will then receive an automatic e-mail with your user id and password. Otherwise please create a new account and then follow the instructions given on the screen. If you already have an existing registration in this system, please DO NOT register again. This will cause delays or prevent the processing of any review or manuscript you submit. If you forgot your username or password click the "Send username/password" button and it will be emailed to you. If you are unsure if you are already registered, click the "Forgot Your Password?" button. If you are registering again because you want to change your current information, changes must be made to your existing information by clicking the "Update My Information" link on the menu bar. If you are unsure how to perform these functions, please contact the editorial office.

GETTING STARTED

Once you have logged into your account, Editorial Manager will lead you through the submission process in a step-by-step orderly process. If you cannot finish your submission in one visit, you can save a draft and re-enter the process at the same point for that manuscript. While submitting your electronic manuscript, you will be required to enter data about your manuscript into the system. These include title, subtitle, author names and affiliations, and so forth. You will be prompted to "enter comments". You will use this field to write your cover letter. The cover letter should make it clear that the final manuscript has been seen and approved by all authors. The authors must state that the paper has not been published (in part or in full) or submitted for publication elsewhere; this includes the tables and figures. The cover letter will not appear in your manuscript.

Support for special characters is available. At any point during this process, there are Help buttons available to see the common questions and a support link to ask a specific question via email. **UPLOADING FILES**

For review purposes, please save and upload your TEXT (Title Page, Text, Acknowledgments, References, Tables, Legends) as one file. Before uploading your text you will be asked to upload the scanned copyright transfer statement signed by all authors (see also instruction to authors: copyright transfer statement). The copyright transfer statement form is regularly published in the journal or may be downloaded from: http://www.springer.com/cda/content/document/cda_downloaddocument/CTS_060213.pdf?SGWID=0-0-45-69724-p1142331.

ILLUSTRATIONS should be uploaded as separate files. If manuscript is accepted for publication, you may need to supply glossies, high resolution JPEG, EPS, or TIFF files. The manuscript text can be uploaded in many formats, including Word and RTF. After uploading the main manuscript file you will be prompted to upload your illustrations (including graphics and pictures) again as separate files. Supported files for illustrations include GIF, JPEG, EPS, TIFF and many others. After uploading the parts of the article in this manner, the system will convert the files to a single PDF file that you need to approve. You will see the results of this conversion with the Acrobat Reader plug-in in your browser. Keep copies of your word-processing and illustration files. You may want to revise the manuscript during the review process and you will need the original files if your manuscript is accepted. At any point during this process, there are Help buttons available to see common questions and a support link to ask a specific question via email. You will also be notified by email that your submission was successful. **Should you have any problem submitting your manuscript online after reviewing the "frequently asked questions" please contact the Editorial office by email at ucclub@gmail.com or by fax or regular mail.**

ILLUSTRATIONS QUALITY

If you are submitting electronic illustrations that you have scanned, be prepared to send the hard copy originals upon request. While the electronic files you have created are satisfactory for the review process, they may not be of sufficient quality for printing. This also holds true for files created in low-resolution graphics environments such as MS Powerpoint, etc. **KEEPING TRACK**

After submission, you may return periodically and monitor the progress of your submission through the review process.

Types of manuscripts accepted

Review articles are subject to the peer review process. Abstract does not need to be structured and they should contain a **maximum of 3,500** words and 120 references.

Original papers should have a structured abstract, **must not exceed 3,000 words** and should not include more than 6 illustrations and tables. Each separate part of a figure (a, b, etc.) counts as an illustration. Up to 45 references are permitted.

Short communications should have a structured abstract and should include brief original studies or techniques with a small number of cases. They should not exceed 1,000 words; 2 illustrations and up to 15 references are permitted.

Case reports describe atypical or unusual clinical entities. Abstract do not need to be structured. Limitations on words, tables and figures and references are the same as for Short communications.

Technical notes include description of an original surgical technique and its application on one or a small number of cases. Follow-up and outcome need to be clearly stated. Abstracts do not need to be structured, they should not exceed 1,000 words; 4 illustrations and up to 10 references.

Tricks of the trade include description of an original surgical, therapeutic or diagnostic manoeuvre that authors found helpful in their practice. They do not have an abstract and must not exceed 600 words with up to 3 figures and 5 references.

Letters to the editors are published in the **Correspondence** section. They must **not exceed 600 words** (and 5 references) with one table or figure and without abstracts. They should be addressed to the Editor-in-Chief. Submitted letters will be subject to shortening and editorial revision.

Techniques in Coloproctology

Last Image. This section publishes high quality photographs illustrating innovative or unusual therapeutic techniques. No abstract, facultative text of maximum 80 words, a minimum of 3 and a maximum of 9 pictures with legends. Only for this type of article color pictures are free of charge.

Preparation of manuscripts

General: The author(s) transfer(s) copyright from his/their article to Springer effective if and when the article is accepted for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For authors from the United States the copyright is transferred to the extent transferable.

All manuscripts must be written in standard grammatical English; this is the responsibility of the author. Manuscripts should be typed with **double-line spacing** throughout, using only one side of standard-sized paper. Margins should be at least 2.5 cm. Three manuscript pages (line width of 65 strokes; 30 lines per page; **double-spaced**) equal one printed page. The form and content should be carefully checked to exclude the need for making corrections later, as authors will receive only one set of page proofs (not galley proofs). Any changes from the manuscript are expensive and will be charged to the author. Essential additions may be placed at the end of the article as a "Note added in proof." The approximate positions of figures and tables must be marked in the margin.

The international (SI) unit system should be used, although other units can be included in parentheses.

Structure: The **first page** should include the following: title of the paper; the first name(s) and surname of each author (name of the author to whom communications should be addressed should be underlined and the postal address, telephone/fax numbers, and **E-MAIL ADDRESS** given); name of the institution or hospital where the work was done, its location, and the source of any support received.

The second page should include: the abstract (no more than 250 words), a short running head of no more than 40 characters (count letters and spaces) and up to 6 key words (terms from the medical subject headings of Index Medicus should be used whenever possible). The rest of the paper should be arranged in the following order: text, acknowledgements, references, tables, figure legends.

Elements of the manuscript

Structured abstract: Abstracts (up to 250 words) should be provided in a structured format and should briefly describe: the problem being addressed in the study, how the study was performed, the results, and what the authors conclude from their results, using the following sections in sequence: **Background**, the exact question(s) addressed by the article. The basic design of the study. The location and level of clinical care; **Methods**, the manner of selection and number of patients or participants who entered and completed the study; the exact treatment or intervention, if any; **Results**, the methods of assessing patients and key results; **Conclusion**, key conclusions including direct clinical applications.

Introduction: The nature and purpose of the work should be outlined briefly, quoting the relevant literature.

Materials and methods: Clinical and technical procedures should be included. Generic names of drugs should be used. If an author desires, brand names may be inserted in parentheses. In the text, authors should state that human studies have been conducted according to the principles established in Helsinki. If studies were approved by an ethical committee, it should be stated. Authors of animal studies should state that they adhered to the guidelines on animal experimentation of a physiological society. The Materials and methods section will be set in small print.

Results: The results should be presented clearly, concisely and without comment.

Discussion: Results should be explained and related to those of other authors; their significance for clinical practice should be defined.

References: The numerals used in the text [which should be put in square brackets] refer to a list of references prepared and numbered in the order of appearance. If abstracts are cited, they must be indicated as such and must not have been published more than 3 years previously. No references can be made to personal communications, unpublished data, theses, or manuscripts submitted or in preparation. Journal names must be abbreviated according to the List of Journals Indexed in the Index Medicus. For 7 or more authors please list the first three authors followed by et al. References should be prepared in the structure of the following examples:

Books: Gullichsen R (1995) Histological and clinical aspects of early healing of the Valtraec anastomosis in the colon. In: Engemann R, Thiede A (eds) *Compression anastomosis by biofragmentable rings*. Springer Berlin Heidelberg, pp 3-5

Articles from electronic publications: Name(s) and initials of all authors, year in parentheses, full title, journal name as abbreviated in Index Medicus, DOI number, and publication date.

With DOI number:

Acknowledgments: These should be limited to people who have contributed significantly to the study.

Conflict of interest: Authors must indicate whether or not they have a financial relationship with the organization that sponsored the research. They should also state that they have full control of all primary data and that they agree to allow the journal to review their data if requested.

Therefore the manuscript must be accompanied by the "Conflict of Interest Disclosure Form".

Illustrations: Figures should be uploaded in the Editorial Manager as separate files. If manuscript is accepted for publication, you need to supply glossies or high resolution JPEG, EPS or TIFF files. Glossy prints of black and white photographs need to have on the back the first author's name and figure number written in soft pencil; an arrow should indicate the top of the figure. The size of the lettering should be consistent in all figures. Each illustration must have a legend of up to four lines (provided on a separate page). Prints can be best reproduced if the print submitted is of a size identical to that desired in the published paper: page width is 17.6 cm; column width is 8.6 cm. Computer drawings are acceptable provided they are of comparable quality to line drawings. Computer-drawn curves and lines must be smooth.

Color illustrations will be accepted, however, the authors will be expected to make a contribution towards the extra costs (approximately € 620,00 for the first and € 320,00 for each additional page plus VAT).

Tables: Each table should be on a separate sheet and numbered consecutively with arabic numerals. A short title should be provided on the same page. Footnotes are indicated with superscript small letters.

Proofs: One copy of the proof product is sent with the manuscript to the author whose name is given for correspondence. The corrected proof should be returned immediately with the manuscript to the publisher by express mail. If proofs are not returned within 48 hours, the paper will be published without the authors' corrections.

Offprints: Offprints may be ordered at cost price when the page proofs are returned. Springer will supply the corresponding authors with 1 copy of the relevant issue.

Failure to comply with the above instructions will result in the manuscript being returned to the author. Manuscripts are examined by the editorial staff and are usually sent to outside reviewers. Authors are encouraged to suggest the names and addresses of possible reviewers, but the editors reserve the right to make the final selection. Authors are usually notified within 3 months if their manuscripts are accepted, but longer delays are sometimes unavoidable.
