Submission of a manuscript implies: that the work described has not been published before (except in the form of an abstract or as part of a published lecture, review, or thesis); that it is not under consideration for publication elsewhere; that its publication has been approved by all co-authors, if any, as well as by the responsible authorities at the institute where the work has been carried out. A written document undersigned by all authors stating agreement with the contents of the article should be remitted. Manuscripts must be accompanied by the "Copyright Transfer Statement." The author(s) transfer(s) the copyright of the article to Springer-Verlag effective if and when the article is accepted for publication.

The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors, the copyright is transferred to the extent transferable. The author(s) guarantee(s) that the manuscript will not be published elsewhere in any other language without the consent of the copyright holders.

Submission of manuscript

Manuscripts in electronic form.

For preparing the electronic form of the manuscript (disquette or CD), Springer offers a user-friendly Word document template.

Please submit your work in two versions:

1. RTF (Rich Text Format) or Microsoft Word compatible formats
2. pdf (a single pdf file including text, tables and figures)

Manuscript preparation

Manuscripts should be printed in double-line spacing with wide margins. The pages should be numbered consecutively, starting with the title page.

Manuscripts should be written in English. Authors who are not sufficiently familiar with the language are advised to seek the help of a colleague whose mother tongue is English.

The desired position of figures and tables should be marked in the margin. Form and content should be checked carefully to exclude the need for corrections in proof. Authors will be charged for changes introduced after the text has been set in type. After acceptance, all manuscripts are subject to copy editing and will, if necessary, be returned to the authors for questions to be answered or for missing information to be supplied before being sent to the printers. When extensive corrections are necessary, authors are responsible for having manuscripts retyped.

Manuscripts are peer reviewed by two or more referees. All editorial decisions are final. Revised manuscripts need to be submitted within 3 months from invitation to revise. Otherwise, such revisions will be treated as new manuscripts.

Organization of the manuscript

The *title* page should comprise: title of paper, first names and last names of all authors; department, institution, city zip code, country, the name of the corresponding

author with telephone and Fax numbers; e-mail address for offprint requests and correspondence; any footnotes referring to the title, word count of abstract and text, number of figures and tables, number of bibliographical references.

An *Abstract* should precede the main text. For articles (regular paper) and reviews, it should not exceed 200 words and must be divided into the following sections: 1) Objective - stating the hypothesis being tested; 2) Materials and Methods - brief but specific to number of subjects, how data were collected and what was done; 3) Results - the findings of the study with statistical significance; 4) Conclusion.

For *Short Communications*, an abstract of not more than 100 words must be submitted and include: 1) reasons to report; 2) what was unique and urgent to be reported. In *Short Communications*, total text should not exceed 2000 words (including abstract and references), illustrations are limited to 3 tables and/or figures and bibliography is limited to 15 references.

Three to five *key words* taken from *Index Medicus* (Medical Subject Headings) should be supplied after the Abstract for indexing purposes.

The *Introduction* should define the subject matter in a few sentences and refer the reader to the most recent reviews for information on earlier work on the same subject. Historical details should not be given.

The *Methods* section should give clear, concise descriptions of patients and/or laboratory animals concerned and specify the equipment, chemical preparations and methods used. A clear description of the statistical analysis employed should also be given.

The *Results* section should describe the outcome of the study. Data should be presented as concisely as possible, if appropriate in the form of tables or figures, although very large tables should be avoided.

In the *Discussion*, the conclusions inferred from the results should be stated. The results should be discussed with reference only to the relevant literature.

Units and abbreviations

Radiation measurements and laboratory values should be given using the *International System of Units (SI)* (source: SI Units in Radiation Protection and Measurements, NCRP Report no. 82 [August 1985]: "Now Read This: The SI Units Are Here." JAMA 1986; 255: 2329-2339). Blood pressure should be given in millimeters of mercury. Abbreviations should be spelled out at first mention in the Abstract and again in the main body of the text, e.g. cerebrospinal fluid (CSF). Laboratory slang, clinical jargon, and uncommon abbreviations should be avoided.

References

The list of *References* should only include works that are cited in the text and that have been published or accepted for publication. Personal communications should only be mentioned in the text. References should be numbered in the order in which they appear in the text and listed in numerical order. Journal titles should be abbreviated according to *Index Medicus*. References should be styled as follows.

Tables

Tables should be typed in double-line spacing on separate pages and numbered with arabic numerals in the order in which they are mentioned in the text. They should be comprehensible without reference to the text. Data from tables should not be repeated in the text or figures.

Figures

All *figures*, whether photographs, graphs or diagrams, should be numbered consecutively throughout and submitted on separate sheets. Plates or single figures may either match the width of the column (8.6 cm), the entire page (17.8 cm), or be 12.8 cm in width with the legend at the side. The maximum height for a figure or plate is 24 cm, including the legend printed at its foot. All photographs and electron micrographs should be supplied as high-contrast glossy prints trimmed at right angles.

If arrows, letters, and numbers are added to prints, they must be of professional quality: alternatively, the desired additions may simply be indicated on a transparent overlay attached to the print.

Prints to be combined in plates, such as anteroposterior and lateral views, should be the same height to facilitate reproduction. They should correspond in appearance to the original radiograph (i.e., showing the bones white on a dark background, with the patient's right to the observer's left, computed tomograms should employ the "view from below"). Overlays may be used to designate the significant points of the illustrations. Color illustrations are accepted; however, the authors will be expected to make a contribution towards the additional costs (approx. 200 Euros per page).

Line drawings should be submitted as good quality glossy prints. The letters should be at least 2 mm high in the printed version. The inscriptions should be clearly legible. Authors who submit a manuscript that reports investigations on human or animal subjects must have conformed to all requirements of the institution and country in which the investigations were carried out and a statement to this effect must be included in the text. The author(s) must guarantee in the cover letter that the reproduction of illustrations in which a patient is recognizable is either approved by the patient him-/herself or his/her legal representative. In all cases, the eyes must be blocked out to prevent identification. The journal assesses no page or publication charges except for color plates and illustrations.

Author responsibility

Written permission must be granted by the publisher and author to reproduce any previously published figures, and any such material must be clearly noted and its source given in the manuscript.

Offprints

Offprints may be ordered in lots of 100 at cost price, provided the order is received with the corrected proofs.

Checklist of requirements

1. Send three copies of the manuscript and three copies of the original illustrations.
2. Double-space all parts of the manuscript.
3. Include a brief Abstract not exceeding 200 words for a full paper or review, and 100 words for a short communication.
4. Give the complete address of the corresponding author, including telephone and Fax numbers, and e-mail address.
5. Include the electronic version of the manuscript (disquette or CD).
6. Include Copyright Transfer Statement and a letter signed by all authors stating that they agree with the contents of the article.
