PDF is not an acceptable format.

MANUSCRIPT STYLE

1. Title Page

List your name, affiliation, and complete address on the title page, providing a daytime telephone number, a fax number and e-mail address if available. Include a brief, one-paragraph abstract of 100–200 words. The abstract should be a carefully worded description of the problem addressed, the key ideas introduced, and the results. Include a list of six or fewer key words. Also, include a shortened version of your title for use on page headings; identify this as the running head.

2. Text

Begin text on a new page following the title page. Papers should be at most 20,000 words in length, with full-page figures counting for 400 words. Use footnotes sparingly, indicating them by consecutive numbers in the text. Include acknowledgments in a separate section at the end of the text.

3. References

References should appear in a separate bibliography at the end of the paper, with items referred to by numerals and put in alphabetical order. References in the text should be denoted by numbers in square brackets, e.g. [12]. References should be complete, in the following style:

Style for papers: Author(s) initials followed by last name for each author, paper title, publication name, volume, inclusive page numbers, month and year.

Style for books: Author(s), title, publisher, location, year, chapter or page numbers (if desired).

Examples as follows:

(Book) D. Marr, *Vision, A Computational Investigation into the Human Representation & Processing of Visual Information*, Freeman: San Francisco, CA, 1982.

(Journal Article) A. Rosenfeld and M. Thurston, "Edge and curve detection for visual scene analysis," *IEEE Trans. Comput.* vol. C.–20 pp. 562–569, 1971.

(Conf. Proceedings) A. Witkin, "Scales space filtering," in *Proc. Int. Joint Conf. Artif. Intell.*, Karlsruhe, West Germany, 1983, pp. 1019–1021.

(Lab. memo.) A.L. Yuille and T. Poggio, "Scaling theorems for zero crossings," *M.I.T. Artif. Intell. Lab.*, Massachusetts Inst. Technol., Cambridge, MA, A.I. Memo. 722, 1983.

4. Spelling and Terminology

Authors should employ technical terms with care, using existing terms when defined by earlier authors and carefully specifying the sense in which they intend ambiguous terms. Please keep abbreviations to a minimum. American spelling is preferred to British spelling.

5. Figures and Tables

- ◆ Figures should be sharp, noise-free, and of good contrast. We regret that we cannot provide drafting or art service.

Author Instructions World Wide Web

- ◆ Each figure should be mentioned in the text and numbered consecutively using Arabic numerals. Each figure must have a caption. Proper style for captions, e.g., "Figure 3. Examples of the fault coverage of random vectors in (a) combinatorial and (b) sequential circuits."
- ◆ Number each table consecutively using Arabic numerals. Please label any material that can be typeset as a table, reserving the term "figure" for material that has been drawn. Specify the desired location of each table in the text. Type a brief title above each table.
- ◆ All lettering should be large enough to permit legible reduction.
- ◆ Suggested figure formats: TIFF, GIF, EPS, PPT, and Postscript. Files should be at least 300 dpi.

PROOFING

Please be sure to include your e-mail address on your paper. If your paper is accepted, we will provide proofs electronically. Your cooperation is appreciated. The proofread copy should be returned to the Publisher within 72 hours.

COPYRIGHT

It is the policy of Springer to own the copyright of all contributions it publishes. To comply with U.S. Copyright Law, authors are required to sign a copyright transfer form before publication. This form returns to authors and their employers full rights to reuse their material for their own purposes. Authors must submit a signed copy of this form with their manuscript.
