

## 1 Legal requirements

Any material received without such evidence will be assumed to originate from the authors.

### Use of animals and human subjects

Manuscripts submitted for publication must contain a statement (at the beginning or at the end of the Methods section) to the effect that all human studies have been approved by the appropriate ethics committee and have therefore been performed in accordance with the ethical standards laid down in the 1964 Declaration of Helsinki. It should also be stated clearly in the text that all persons gave their informed consent prior to their inclusion in the study. Details that might disclose the identity of the subjects under study should be omitted.

Reports of animal experiments must state that the "Principles of laboratory animal care" (NIH publication No. 86-23, revised 1985) were followed, as well as specific national laws (e.g. the current version of the German Law on the Protection of Animals), where applicable. The Editors reserve the right to reject manuscripts that do not comply with the above-mentioned requirements. The author will be held responsible for false statements or for failure to fulfil the above-mentioned requirements.

**B. Manuscript submission:** Authors are requested to submit their manuscripts in English via the journal's manuscriptCentral site at <http://ejap.manuscriptCentral.com>

C. Manuscripts must be accompanied by the *Copyright Transfer Statement* ([springeronline.com/journal/00421](http://springeronline.com/journal/00421)). A signed copy of the *Copyright Transfer Statement* must be transmitted by fax and by mail to the Editor in Chief upon submission of the manuscript. The review process will not be initiated until a copy of the *Copyright Transfer Statement* has been received by the Editorial Office.

## 3 Manuscript structure

All manuscripts are subject to copy editing. To facilitate rapid publication manuscripts should be prepared carefully in accordance with the following requirement. The elements of the manuscript are to be arranged in the following sequence: Title page (numbered as page 1), Abstract, Key-words, Introduction, Methods, Technique or Case histories, Results, Discussion (comments and comparison with other published results), Acknowledgements, References, Tables, Legends, Illustrations.

The **title page** should contain:

1. The names of the authors.
2. The title of the paper.
3. The authors' affiliations. Addresses should be complete and may be given in the local language. An envelope symbol should be used to indicate the author to whom correspondence should be sent.
4. The fax and e-mail numbers of the corresponding author.

Page 2 should start with a concise, factual **Abstract** of the most important results and conclusions in no more than 250 words. Immediately following the abstract **no more than 5 Key-words** are to be supplied for subject indexing. They should not simply be taken from the title of the article but should be representative of the content of the whole article and characteristic of the terminology used within the particular field of study. They should be taken from *Index Medicus* (Medical Subject Headings) or, failing this, be composed by analogy on the same principle.

All **abbreviations** should be explained in parentheses after the full written-out version of what they stand for on their first occurrence in the Abstract and again in the main body of the text. All unit abbreviations should use the power convention, e.g.  $1 \text{ min}^{-1}$ .

**Système international d'unités (SI).** SI units should be used for the numerical expression of the results of measurements. In cases in which the SI unit is different from the conventional one, the conventional unit should be added in parentheses; e.g., 12 kPa (90 mm Hg). Authors are referred to the **Glossary of terms for thermal physiology** published in Volume 57, Number 1 of the journal.

**Footnotes** to the text should be numbered consecutively and placed at the bottom of the page to which they refer.

### References

The list of references should include only works that are cited in the text and that have been published or accepted for publication. Personal communications should be mentioned in the

text only. Journal titles should be abbreviated according to *Index Medicus*.

References should be cited by author and year in the text (e.g. Hammer 1994; Hammer and Sjöqvist 1995; Hammer et al. 1993) and listed in alphabetical order in the reference list. Examples:

### References with correct punctuation should be styled as follows:

If available the **Digital Object Identifier (DOI)** of the cited literature should be added at the end of the reference in question.

### Illustrations and Tables

All figures (photographs, graphs or diagrams) and tables should be cited in the text, and each numbered consecutively throughout. Lowercase letters (a, b etc.) should be used to identify figure parts. If illustrations are supplied with uppercase labeling, lowercase letters will still be used in the figure legends and citations.

**Half-tone illustrations** (black and white and colour). For colour illustrations the authors will be expected to make a contribution (€ 485, US \$ 435, plus 16% VAT) towards the extra costs, irrespective of the number of colour figures.

Magnification should be indicated by *scale bars*. Details that might identify patients should be omitted unless absolutely necessary for scientific reasons. Falsification or altering of data should never be used as a means of ensuring anonymity; masking of the eye region in photographs of patients may be inadequate. If identification of patients is unavoidable, the author must guarantee that the reproduction of illustrations in which a patient is recognizable is approved either by the patient him-/herself or by his/her legal representative.

**Figure legends** must be brief, self-sufficient explanations of the illustrations. The legends should be placed at the end of the text.

**Tables** should have a title and a legend explaining any abbreviation used in that table. Footnotes to tables should be indicated by superscript lower-case letters (or asterisks for significance values and other statistical data).

The preferred figure formats are EPS for vector graphics exported from a drawing program and TIFF for halftone illustrations. EPS files must always contain a preview in TIFF of the figure. The file name (one file for each figure) should include the figure number. Figure legends should be included in the text and not in the figure file.

- **Scan resolution:** Scanned line drawings should be digitized with a minimum resolution of 800 dpi relative to the final figure size. For digital halftones, 300 dpi is usually sufficient.
- **Colour illustrations:** Store colour illustrations as RGB (8 bits per channel) in TIFF format.

#### Preparing your manuscript

Please follow the instructions provided in the Author Center of ManuscriptCentral.

#### Layout guidelines

1. Use a normal, plain font (e.g., Times Roman) for text.  
Other style options:  
– for textual emphasis use *italic* types.  
Use the automatic page numbering function to number the pages.
2. Do not use field functions.
3. For indents use tab stops or other commands, not the space bar.
4. Use the table functions of your word processing program, not spreadsheets, to make tables.
5. Use the equation editor of your word processing program or MathType for equations.
6. Place any figure legends or tables at the end of the manuscript.
7. Submit all figures as separate files and do not integrate them within the text.

#### Data formats

Prepare your manuscript using a word processing program and save it as a .doc, .rtf or .ps file. You may also upload .xls or .ppt supplemental files as part of the manuscript submission process. All of these files will be automatically converted to .pdf format. Image files such as .gif, .jpg, .eps, .png, and .tif may be uploaded. These will be converted to small .jpg files. In any case, a .doc, .rtf or .ps file must be uploaded.

#### 4 Electronic supplementary material

Electronic supplementary material (ESM) for an article in the journal will be published in SpringerLink provided the material is:

- submitted to the Editor(s) in electronic form together with the paper and is subject to peer review.
- accepted by the journals Editor(s).

ESM may consist of:

- information that cannot be printed animations, video clips, sound recordings.
- information that is more convenient in electronic form: sequences, spectral data, etc.
- large original data that relate to the paper e.g. additional tables, illustrations (color and black & white), etc.

After acceptance by the journals Editor(s) ESM will be published as received from the

author in the online version only. Reference will be given in the printed version.

#### 5 Short communications

Short communications are limited to 3 printed pages (ca. 12,000 characters), including a maximum of two figures/tables and 8 references.

#### 6 Proofreading

Authors should make their proof corrections on a printout of the pdf file supplied, checking that the text is complete and that all figures and tables are included. After online publication, further changes can only be made in the form of an Erratum, which will be hyperlinked to the article. The author is entitled to formal corrections only. Substantial changes in content, e.g. new results, corrected values, title and authorship are not allowed without the approval of the responsible editor. In such a case please contact the appropriate editor before returning the proofs to the publisher.

#### 7 Offprints

Two (2) complimentary copies of the journal issue in which the article is published will be supplied, free of charge, to the corresponding author. Orders for offprints can be placed by returning the order form with the correct proofs. When you order offprints, you are entitled to receive in addition a pdf file of your article for your own personal use.
