Peer Review

Members of *BioPharm International's* Editorial Advisory Board and other industry experts review all technical manuscripts. *Reviews are blind.* Readers, vendors, and product manufacturers are all best served when authors present their scientific and technical data and conclusions in a straightforward and neutral way. *BioPharm International* readers know that the magazine's editors and reviewers insist on solid data to support an article's conclusions. Reviewers expect authors to resist the pressure to emphasize product names in their work, and they recommend rejection of manuscripts that look promotional.

Types of Manuscripts and Submissions

Manuscripts fall into several categories: articles, reviews, technical notes, tutorials, and opinion pieces. The editors will decide which format will most effectively showcase your article or submission.

How to Submit a Manuscript

Please submit your text electronically, either on a ZIP disk or as an attachment to editor in chief Carol Fisher at cfisher@advanstar.com. If you have any questions about file formats, please call us at 732.346.3061. To expedite the review process, please

- remove all headers and footers
- do not embed your endnotes
- do not embed (insert) scanned figures,

photos, or tables into the text version, but send those in a separate file. If we cannot obtain a good, clear copy of a figure from an electronic file (especially in the case of gels and graphs), we might have to ask you for a camera-ready hard copy or for plot points. *Please do not send*

us your only copy of figures or photos!

Next, mail your article to us for reference (especially important if your paper includes equations or special characters that might be lost in file translation). The printing must be on one side of the paper only, double-spaced, with generous margins (1.5 inches) all around. Number all pages consecutively. Identify authors only on the title page (which is removed for reviews); make sure there are no names in headers or footers. Place each table on a separate sheet of paper; start figure legends on a separate page, and identify each by its proper number. Explain all symbols used in the illustrations.

Exclusivity and Copyright

All manuscripts are reviewed with the understanding that they have never been published and that they are not under consideration elsewhere. If illustrations or tabular data used in the manuscript have been published, the author is responsible for obtaining permission to use them from the copyright holder. Once the article is accepted for publication, we will send you a copyright release form to sign and return to us.

How Long Does It Take?

Manuscript review. Locating reviewers and receiving their comments usually takes three to four weeks. We send authors the reviewers' comments and queries along with detailed guidance for revisions.

Reviewers often ask several substantive questions and/or recommend a number of revisions. When they are fundamentally satisfied with an article or have only minor queries or requests, we can often work out revisions by telephone. *BioPharm International* returns rejected manuscripts only on request. *BPI*
