INTRODUCTION

Manuscript Submission

Manuscripts for IMR should be submitted online via Editorial Manager (www.editorialmanager.com/IMRES/).

Manuscripts must be typed in English, 1.5- or double-spaced and 11- or 12-point font, using 1-inch (2.54 cm) margins. All pages must be numbered consecutively. Manuscript file should include a title page, manuscript text with section numbering, disclosure statements, references, tables, and figure legends, as a single file. ORCID iD is mandatory for all authors. Authors are required to be in compliance with the Uniform Requirements for Manuscripts Submitted to Biomedical Journals, which are compiled by the International Committee of Medical Journal Editors (ICMJE), available at www.icmje.org

Please ensure that the following submission documents and information are also included: A cover letter. It must include the corresponding author's name, address, telephone number and e-mail address. Disclosure statements (all mandatory): author contributions (CRediT), conflict of interests, funding, ethical statement, and data availability. Relevant reporting checklist: Authors are required to adhere their manuscripts to recognized reporting guidelines (refer to 3.1 Reporting guidelines) and submit the checklist during submission. Articles covering the use of human subjects in research (including trials and survey) must be approved by the research ethics review committee and their approval should be indicated in the manuscript. Articles where human subjects can be identified in descriptions, photographs or pedigrees must be accompanied by a statement of informed consent to publish (in print and online). Clinical trials are recommended to register at a clinical trial

registration website such as <https://clinicaltrials.gov> or other primary registries recognized by WHO and the ICMJE which can be found at: www.who.int/clinical-trials-registry-platform/network/primary-registries Articles covering the use of animals in experiments must be approved by the relevant authorities. Where material has been reproduced from other copyrighted sources, the letter(s) of permission from the copyright holder(s) to use the copyrighted sources must be supplied. For non-native English-speaking authors, manuscripts should be checked and edited by a native English speaker or by professional English editing services.

Types of article

Editorials

Editorials are invited articles or comments concerning a specific paper in the Journal or a topical issue in the field. Although editorials are normally invited or written by an Editor, unsolicited editorials may be submitted.

Commentaries

These are short, opinion articles which focus on current research topics and highlight articles of interest previously published elsewhere. Commentaries are generally invited by the Editors, but interested contributors with unsolicited commentaries are encouraged to submit them.

Review Articles

These should aim to provide the reader with a balanced overview of an important and topical subject within the Journal's aims and scope. The review should have a clear methodology of reviewing the contents for systematic reviews, narrative reviews and any other types of reviews. Most reviews are solicited by the editors, but unsolicited submissions may also be considered for publication.

Original Articles

These may be clinical trials, cohort studies, diagnostic test accuracy studies, cost-effectiveness analyses, surveys, animal studies, and other research studies on integrative medicine and health, which represent new and significant contributions to the field.

Short communications

These are short reports of significant research. Short communications may include up to 2 figures or tables.

Case Reports

These are short discussions of a case or case series with unique features not previously described that make an important teaching point or scientific observation. Case reports should include the significance and purpose of the case presentation, the diagnostic methods of the case, the key data, and brief comments and suggestions with regard to the case. Refer to the CARE guidelines and submit CARE checklist with the case report manuscript.

Letters to the Editor

These include brief constructive comments concerning previously published articles in the journal or very brief research reports. Letters are edited, sometimes extensively, to sharpen their focus. They may be sent for peer review at the discretion of the Editors.

BEFORE YOU BEGIN

Reporting guidelines

Authors are required to adhere their manuscripts to recognized reporting guidelines where appropriate, and submit a relevant, completed checklist. Depending on the research design used, more specific extensions may be necessary. Below is the list of sample reporting guidelines: Randomized controlled trials - CONSORT Systematic review or meta-analysis - PRISMA Observational studies - STROBE Case reports - CARE Animal research - ARRIVE For other reporting guidelines, authors may refer to the Equator Network (Enhancing the QUALity and Transparency Of health Research, <http://www.equator-network.org/>).

Studies in humans and animals

If the work involves the use of human subjects, the author should ensure that the work described has been carried out in accordance with the World Medical Association Declaration of Helsinki - Ethical Principles for Medical Research Involving Human Subjects, <https://www.wma.net/policies-post/wma-declaration-of-helsinki-ethical-principles-for-medical-research-involving-human-subjects/>, the International Committee of Medical Journal Editors Recommendations for the Conduct, Reporting, Editing and Publication of Scholarly Work in Medical Journals, <http://www.icmje.org/recommendations/>. The privacy rights of human subjects must always be observed.

Authors should include a statement in the manuscript that informed consent and an approval by the institutional review board (ethics committee) were obtained for research with human subjects. The IRB approval number should be stated.

All animal experiments should be carried out in accordance with the U.K. Animals (Scientific Procedures) Act 1986 and associated guidelines, EU Directive 2010/63/EU for animal experiments, or the National Institutes of Health guide for the care and use of laboratory animals (NIH Publications No. 8023, revised 1978), and comply with the ARRIVE guidelines. The authors should clearly indicate in the manuscript that such guidelines have been followed and an approval by the animal ethics committee has been obtained. All animal studies need to ensure they comply with the ARRIVE guidelines.

Submission declaration and verification

Submission of an article implies that the work described has not been published previously (except in the form of an abstract or as part of a published lecture or academic thesis or as an electronic preprint, see <https://www.elsevier.com/about/policies/sharing>), that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities where the work was carried out, and that, if accepted, it will not be published elsewhere, including electronically, in the same form, in English or in any other language, without the written consent of the copyright-holder. To verify originality, your article may be checked by the originality detection service Crossref Similarity Check: <https://www.elsevier.com/editors/perk/plagiarism-complaints/plagiarism-detection>.

These guidelines are meant as a point of reference to help identify appropriate language but are by no means exhaustive or definitive.

Changes to authorship

Authors are expected to consider carefully the list and order of authors before submitting their manuscript and provide the definitive list of authors at the time of the original submission. Any addition, deletion or rearrangement of author names in the authorship list should be made only before the manuscript has been accepted and only if approved by the journal Editors. To request such a change before acceptance, the editors must receive the following from the corresponding author: (a) the reason for the change in author list and (b) written confirmation (letter signed by all authors) that they agree with the addition, removal or rearrangement. In the case of addition or removal of authors, this includes confirmation from the author being added or removed. Only in exceptional

circumstances will the editors consider the addition, deletion or rearrangement of authors after the manuscript has been accepted. While the Editor considers the request, publication of the manuscript will be suspended. If the manuscript has already been published in an online issue, any requests approved by the Editors will result in a corrigendum.

Copyright

Published manuscripts become the permanent property of Korea Institute of Oriental Medicine, and must not be published elsewhere without written permission. All articles published in the Journal are protected by copyright, which covers the exclusive rights to reproduce and distribute the article, as well as translation rights. No part of this publication may be reproduced, stored in any retrieval system, or transmitted in any form or by any means, electronic, mechanical, by photocopying, recording, or otherwise, without prior written permission from Korea Institute of Oriental Medicine. A copyright transfer form should be signed by all co-authors. Every peer-reviewed article appearing in this journal will be published open access. This means that the article is universally and freely accessible via the internet in perpetuity, in an easily readable format immediately after publication. The author does not have any publication charges for open access. Korea Institute of Oriental Medicine will pay to make the article open access.

Acknowledgments

If applicable, general acknowledgments for consultations, statistical analysis, etc., should be listed after main body of text, before the references, including the names of the individuals involved. All financial and material support for the research and the work should be stated in "Funding" instead.

Author contributions

The journal uses the CRediT taxonomy to define author contributions. Each author on a paper may have one or more CRediT contribution roles. CRediT author contribution statements should be provided during the submission. For more details on CRediT, see <https://www.elsevier.com/authors/journal-authors/policies-and-ethics/credit-author-statement>.

Conflicts of Interests

The corresponding author must inform the editor of any potential conflicts of interest that could influence the author's interpretation of the data or influence the acceptance of the manuscript. Conflict of interest statements will be published at the end of the article with other disclosures, before the References section. Any financial support (funds) received for the study must be stated at the end of the manuscript. If the sponsor took any role in the following, then briefly describe the role: in study design; in the collection, analysis and interpretation of data; in the writing of the report; and in the decision to submit the article for publication. If the funding source had no such involvement then this should be stated. Even when no funding was received, it should be stated as "none."

Ethical statement

Studies on humans or animals require relevant ethics committee approval and the approval number should be stated. For human subjects, an informed consent should also be retained by the author and documented in the paper. In exceptional circumstances (for example if a legal issue arises), the journal may request copies of the consents or evidence that such consents have been obtained. Unless

the authors have written permission from the patient, the personal details of any patient included in any part of the article and in any supplementary materials must be removed before submission. For studies not involving human or animal, it should be stated that no ethics approval was needed.

Data availability

To foster transparency, stating the availability of the data is mandatory for the journal. If authors choose to publish their data, the data can be placed in a repository of their choice and its DOI can be stated in the data availability statement. Other options, for example, are to state that "The data will be made available upon request." With the data statement, the authors can be transparent about the data they used in an article. Submission

Submissions are submitted and reviewed online using the Editorial Manager. The system automatically collects some information from the uploaded files so that the authors do not have to manually input all the information. All the files are converted in to a single PDF file to be used in the review process. Authors should check the PDF and submission details on the system as technical errors may occur. Editable files (e.g., Word) are required to typeset your article for final publication. All correspondence, including notification of the Editor's decision and requests for revision, is sent by e-mail which can also be checked on the Editorial Manager.

Discussion Acknowledgment (if any) Author contributions (mandatory) Conflict of interest (mandatory) Funding (mandatory) Ethical statement (mandatory) Data availability (mandatory) Supplementary material as a single file (if any) References Tables (placed at the end of the manuscript) Figure legend

Title page

The title page should be compiled to the manuscript as a single file. The title page should include: category of paper, article title (full title and short running title), full names of all authors, institutions of authors (indicate all affiliations with a superscripted lowercase number after the author's name and in front of the appropriate affiliation), all contributing authors' ORCID iD numbers, and the corresponding author details (name, full address, ORCID iD, and e-mail). The journal allows up to two co-corresponding authors which should be indicated on the title page using an asterisk (*).

Abstract

An abstract is required for the following article categories: Review Article, Original Article, and Case Report, and Short Communication Abstracts should be no more than 250 words in length. Abstracts should be structured, with the following section headings: Background, Methods, Results and Conclusion. For clinical trials, trial registration information (registry name, number and site) should also be included at the end of the Abstract.

Keywords

3-5 relevant keywords are required for all articles. For selecting keywords, authors may refer to the Medical Subject Headings (MeSH) at the U.S. National Library of Medicine: <https://meshb.nlm.nih.gov/search>.

Main Text

The text for Original Articles, for example, should include the following sections: 1. Introduction, 2. Methods, 3. Results, and 4. Discussion. The Introduction should be as concise as possible, without subheadings. The Methods section should be sufficiently detailed. Subheadings may be used to organize the Methods, Results and Discussion. Limitations and conclusions should be included in Discussion. All sections should be numbered.

Abbreviations

Where a term/definition is continually referred to (i.e. ≥ 3 times in the text), write it in full when it first appears, followed by the subsequent abbreviation in parentheses (even if it was previously defined in the abstract); thereafter, the abbreviation can be used.

Scientific names

A formal scientific name conforming to the International Code of Nomenclature should be adhered to. For genes, standard international nomenclature for genes should be adhered to. For human genes, use genetic notation and symbols approved by the HUGO Gene Nomenclature Committee (www.genenames.org) or refer to PubMed (www.ncbi.nlm.nih.gov).

Units

The International System of Units (SI) must be used, with the exception of blood pressure values which are to be reported in mmHg. Please use the metric system for the expression of length, mass, volume, etc.

References

Authors are responsible for the accuracy and completeness of their references and for correct in-text citation.

In the main text, tables and figure legends References should be identified using superscripted numbers, in numerical order, and be placed after punctuation. References cited in tables or figure legends should be included in sequence at the point where the table or figure is first mentioned in the main text. Do not cite abstracts unless they are the only available reference to an important concept. Uncompleted work or work that has not yet been accepted for publication (i.e., "unpublished observation", "personal communication") are not recommended to be cited as references.

In the references list References should be limited to those cited in the text and listed in the order in which they appear in the text. References for journal articles should include, in the order of authors' last name and initials, article title, abbreviated journal title, year, volume and inclusive page numbers or article number. When there are more than 6 authors, the last names and initials the first 6 authors should be included, followed by "et al". Abbreviated journal titles should conform to those used in MEDLINE. If citing a website, provide the author information, article title, website address and the date you accessed the information. Reference to an article that is in press must state the journal title, digital object identifier (DOI), and, if possible, the year and volume.

Tables

Tables are numbered consecutively, in the order of their citation in the text. Tables should be placed at the end of the manuscript. Table legend example: **Table 1.** Demographic characteristics of patients [note: "**Table 1.**" in bold font with end period; no end period after legend]. Shortening of some words inside table: year(s) · yr; month(s) · mo; day(s) · d; hour(s) · hr; minute(s) · min; second(s) · sec; and · &. Use en dashes for empty entries. Footnotes are indicated using these symbols (in order of appearance): *, †, ‡, §, ||, ¶, * * [note: when > 10 footnotes, use superscripted lowercase letters]. Abbreviations used in the table, even when already defined in the text, should be defined and placed after the footnotes and presented like in this example: CT, computed tomography; MRI, magnetic resonance imaging. [note: the use of "," with a space on either side, semi-colon to separate, and a period after the last].

Figures

Figure legends should be submitted for all figures and should be brief and specific and placed on a separate sheet after the reference section. Figure legend example: Fig. 1. Demographic characteristics of patients. Figures must be in numerical order using Arabic numerals in the order of their citation in the text. Figures should be uploaded as separate files, not embedded in the manuscript file.

Regardless of the application used, when your electronic artwork is finalized, please "save as" or convert the images to one of the following formats (note the resolution requirements for line drawings, halftones, and line/halftone combinations given below):

- EPS: Vector drawings. Embed the font or save the text as "graphics".
- TIFF: Color or grayscale photographs (halftones)-use a minimum of 300 dpi.
- TIFF: Bitmapped line drawings-use a minimum of 1000 dpi.
- TIFF: Combination of bitmapped line/half-tone (color or grayscale)-use a minimum of 600 dpi.
- DOC, XLS or PPT: If your electronic artwork is created in any of these Microsoft Office applications, please supply "as is".

Please do not:

- Supply files that are optimized for screen use (like GIF, BMP, PICT, WPG) as the resolution is too low;
- Supply files that are too low in resolution;
- Submit graphics that are disproportionately large for the content.

REVIEW AND ACTION

The Editorial and Peer Review Process

As a general rule, the receipt of a manuscript will be acknowledged within 2 weeks of submission; authors will be provided with a manuscript reference number for future correspondence. If an acknowledgment is not received in a reasonable period of time, the author should contact the Editorial Office (imr@kiom.re.kr).

Submissions are reviewed by the Editorial Office to ensure that it contains all parts. Submissions will be rejected if the author has not supplied all the material and documents as outlined in the Journal's author guidelines. Manuscripts are then reviewed by the Editors, who make an initial assessment. If the manuscript does not appear to be of sufficient merit or is not appropriate for the Journal, the manuscript will be rejected without review. All other manuscripts are sent to 2 or more expert consultants for single-blind peer review. Authors will usually be notified within 12 weeks of the initial acknowledgment of whether the manuscript is accepted for publication, rejected, or subject to revision before acceptance. However, do note that delays are sometimes unavoidable.

Appeals regarding manuscripts rejected by Integrative Medicine Research

Integrative Medicine Research is able to consider only a relatively small percentage of submissions received for publication. Therefore, many good manuscripts are rejected without peer reviews. If your paper is declined without peer review, please do not appeal the decision. Doing so distracts the journal's editors and reviewers from evaluating submissions and processing other manuscripts. If, however, the reviewer or editor evaluations are needed to be reassessed, the Editor-in-Chief will consider an appeal and reopen the manuscript's file.

Any appeal must be made by the corresponding author to the Editorial Office by email prior to resubmitting the manuscript. Please do not resubmit a revised version of a rejected manuscript without an appeal to the Editorial office. Please do not resubmit until your original manuscript is released back to you. By waiting for the manuscript release, it ensures that your paper is processed under the same manuscript number, keeping the manuscript history intact.

Occasionally, a manuscript is rejected but the Editorial Board offers the option to resubmit a revised, abridged version as a Letter or Commentary.

Special issue organization

Manuscripts submitted for special issues are handled by guest editors and peer reviewed by 2 or more reviewers. The editorial decision is made by the handling guest editor who organize the special issue, and the final decision is made by the Editor-in-Chief.

Use of the Digital Object Identifier

The Digital Object Identifier (DOI) may be used to cite and link to electronic documents. The DOI consists of a unique alpha-numeric character string which is assigned to a document by the publisher upon the initial electronic publication. The assigned DOI never changes. Therefore, it is an ideal medium for citing a document, particularly 'Articles in press' because they have not yet received their full bibliographic information. Example of a correctly given DOI (in URL format; here an article in the journal Physics Letters B): <http://dx.doi.org/10.1016/j.physletb.2010.09.059>. When you use a DOI to create links to documents on the web, the DOIs are guaranteed never to change.

Proofs

Corresponding authors will receive an e-mail with a link to our online proofing system, allowing annotation and correction of proofs online. The environment is similar to MS Word: in addition to editing text, you can also comment on figures/tables and answer questions from the Copy Editor. Web-based proofing provides a faster and less error-prone process by allowing you to directly type your corrections, eliminating the potential introduction of errors. All instructions for proofing will be given in the e-mail we send to authors, including alternative methods to the online version and PDF. We will do everything possible to get your article published quickly and accurately. Please use this proof only for checking the typesetting, editing, completeness and correctness of the text, tables and figures. Significant changes to the article as accepted for publication will only be considered at this stage with permission from the Editor. It is important to ensure that all corrections are sent back to us in one communication. Please check carefully before replying, as inclusion of any subsequent corrections cannot be guaranteed. Proofreading is solely your responsibility.

PEER REVIEW

This journal operates a single blind review process. All contributions will be initially assessed by the editor for suitability for the journal. Papers deemed suitable are then typically sent to a minimum of two independent expert reviewers to assess the scientific quality of the paper. The Editor is responsible for the final decision regarding acceptance or rejection of articles. The Editor's decision is final. [More information on types of peer review.](#)

Data references
