

Instructions for Authors

Online Manuscript Submission

Springer now offers authors, editors and reviewers of Applied Composite Materials the option of using our fully web-enabled online manuscript submission and review system. To keep the review time as short as possible (no postal delays!), we encourage authors to submit manuscripts online to the journal's editorial office. Our online manuscript submission and review system offers authors the option to track the progress of the review process of manuscripts in real time. Manuscripts should be submitted to: <http://acma.edmgr.com> The online manuscript submission and review system for Applied Composite Materials offers easy and straightforward log-in and submission procedures. This system supports a wide range of submission file formats: for manuscripts - Word, WordPerfect, RTF, TXT and LaTeX; for figures - TIFF, GIF, JPEG, EPS, PPT, and Postscript.

NOTE: By using the online manuscript submission and review system, it is NOT necessary to submit the manuscript also in printout + disk.

Hard-copy figures

Original or good quality printouts of all figures should be submitted with the manuscript. Computer generated printouts should be flawless and on good quality paper. Non-computer generated line figures should be drawn with Indian ink on white matt paper or tracing paper. Photographs should be in black and white on glossy paper. If a figure is to be in colour (author's expense), please supply the highest quality possible so that the figure can be scanned. Slides, glossy photos and computer generated printouts on glossy photo quality paper are acceptable. On the reverse side of each figure, the name of the (first) author and the figure number should be written in pencil; the top of the figure should be clearly indicated.

Electronic figures

You should supply the electronic versions of your figures. We prefer figures in TIFF, EPS, PS, PDF and Microsoft® Office format. Be aware that we may not be able to use other file formats and that the hard copy may be scanned instead. For vector graphics, EPS is the preferred format. For bitmapped graphics, TIFF is the preferred format. The following resolutions are optimal: line figures - 600 – 1200 dpi; photographs - 300 dpi; screen dumps - leave as is. Colour figures can be submitted in the RGB colour system. Font-related problems can be avoided by using standard fonts such as Times Roman, Courier and Helvetica. Figures should be saved in separate files. The figure legends should be included in the text file.

Language

We appreciate any efforts that you make to ensure that the language is corrected before submission. This will greatly improve the legibility of your paper if English is not your first language.

Manuscript Presentation

The journals language is English. British English or American English spelling and terminology may be used, but either one should be followed consistently throughout the article. Leave adequate margins on all sides to allow reviewers remarks. Please double-space all material, including notes and references. Number the pages consecutively with the first page containing:

Running head (shortened title)

- title
- author(s)
- affiliation(s)
- full address for correspondence, including telephone and fax numbers and E-mail address

Abstract

Please provide a short abstract of not more than 250 words which clearly summarises the paper. The abstract should not contain any undefined abbreviations or unspecified references.

Key Words

Key words supplied by the author should appear on a line following the abstract. The key words selected should be comprehensive and subject specific. It is not necessary to list the subject area of the Journal's coverage as a key word. General terms should not appear as key words, as they have little use as information retrieval tools. Please, choose key words to be as specific as possible, and list the most specific first, proceeding to the most general last.

Units

All scientific and technical data presented should be stated in SI units, except in unavoidable circumstances.

Footnotes

Footnotes should be kept to an absolute minimum and used only when essential.

Formulae

Formulae in manuscripts submitted for conventional typesetting should be type-written whenever possible. Alternatively, a fine drawing pen and black ink should be used, it is extremely important that all

mathematical symbols and letters used are identified and listed and that the required style of appearance of such symbols is clearly indicated, e.g., bold face, italics, script, outline, fraktur, etc. Sub- and super-script should be clearly indicated where confusion might arise. Use a full stop as a decimal sign. Identify in the margin any symbols that might be confused with similar symbols, e.g. letter l and figure 1, capital letter O and figure 0, letter e, etc.

References

References should be listed in numerical order, and should be numbered in the text between square brackets. The format for referencing books and articles in books and journals is:

Ferry, J.D., *Viscoelastic Properties of Polymers*, Wiley, New York, 1980.

Figures

All photographs, graphs and diagrams should be referred to as a 'Figure' and they should be numbered consecutively (1, 2, etc.). Multi-part figures ought to be labeled with lower case letters (a, b, etc.). Please insert keys and scale bars directly in the figures. Relatively small text and great variation in text sizes within figures should be avoided as figures are often reduced in size. Figures may be sized to fit approximately within the column(s) of the journal. Provide a detailed legend (without abbreviations) to each figure, refer to the figure in the text and note its approximate location in the margin. Please place the legends in the manuscript after the references.

Tables

Each table should be numbered consecutively (1, 2, etc.). In tables, footnotes are preferable to long explanatory material in either the heading or body of the table. Such explanatory footnotes, identified by superscript letters, should be placed immediately below the table. Please provide a caption (without abbreviations) to each table, refer to the table in the text and note its approximate location in the margin. Finally, please place the tables after the figure legends in the manuscript.

Proofs

Proofs will be sent to the corresponding author by e-mail (if no e-mail address is available or appears to be out of order, proofs will be sent by regular mail).

Your response, with or without corrections, should be sent within 72 hours. Please do not make any corrections to the PDF file. Minor corrections (10) should be sent as an e-mail attachment to: proofscorrection@springer-sbm.com. Always quote the four-letter journal code and article number and the PIPS No. from your proof in the subject field of your e-mail. Extensive corrections must be clearly marked on a printout of the PDF file and should be sent by firstclass mail (airmail overseas).

In the case of proofs not being returned in time, they may be read by the Editor against a second copy of the manuscript and passed for publication without the author's comment.

Offprints

Fifty offprints of each article will be provided free of charge. Additional offprints (both hard copies and PDF files) can be ordered by means of an offprint order form supplied with the proofs.

Page Charges

No page charges are levied on authors or their institutions. An exception will be made for special extras such as fold-outs and colour reproductions.

Copyright

Authors will be asked, upon acceptance of an article, to transfer copyright of the article to the publisher. This will ensure the widest possible dissemination of information under copyright laws.

Springer Open Choice

In addition to the normal publication process (whereby an article is submitted to the journal and access to that article is granted to customers who have purchased a subscription), Springer now provides an alternative publishing option: Springer Open Choice. A Springer Open Choice article receives all the benefits of a regular subscription-based article, but in addition is made available publicly through Springer's online platform SpringerLink.
