

Instructions for Authors

PREPARATION OF MANUSCRIPT

A submitted manuscript, which undergoes peer review, must be an original contribution not previously published (except as an abstract or preliminary report), must not be under consideration for publication elsewhere, and, if accepted, must not be published elsewhere in similar form, in any language, without the consent of Lippincott Williams & Wilkins. Although the editors and referees make every effort to ensure the validity of published manuscripts, the final responsibility rests with the authors, not with the Journal, its editors, or the publisher.

Patient anonymity/informed consent: It is the author's responsibility to ensure that a patient's anonymity is carefully protected and verify that any experimental investigation with human subjects reported was performed with informed consent and following all guidelines for experimental investigation with human subjects required by the institution(s) with which all the authors are affiliated.

Permissions: Authors must submit written permission from copyright owners (usually a publisher) to use lengthy direct quotations, tables, or illustrations that have appeared in copyrighted form elsewhere.

General format: Manuscripts should be double-spaced and formatted for 8½ x 11-inch paper with at least a 1-inch margin on all sides.

Title page: manuscript title; authors' full names, highest academic degrees, and affiliations; name, address, telephone number, and email for corresponding author; sources of support requiring acknowledgment, and disclosure of funding for this work from any of the following organizations: National Institutes of Health (NIH); Wellcome Trust; Howard Hughes Medical Institute (HHMI); or industry.

Abstract and key words: 250 words plus at least 5 key words.

Text: Use headings to clarify organization. Indicate where tables and figures should appear. Define abbreviations at first mention in the text and in each table and figure.

References: Authors are responsible for accuracy of references. Place references at end of the manuscript and cite in text in order of appearance. Cite unpublished data (papers submitted but not yet accepted, personal communications) in parentheses in the text. If more than 3 authors, list first three and then use et al. Use Index Medicus abbreviations for journal names (www.nlm.nih.gov/tsd/serials/lji.html). Samples are given below:

Figures: Cite and number figures consecutively in the text. Submit figures in electronic form (e.g., pdf, tiff, eps files). Include brief legends for all figures at the end of the manuscript after the references.

Tables: Tables should supplement, rather than duplicate, material in the text. Cite and number tables consecutively in the text and place them at the end of the manuscript. Include table title, column heads, and explanatory legends (including definitions of abbreviations).

Supplemental Digital Content (SDC): Authors may submit SDC that enhances the article's content to be considered for online posting. Submit SDC (e.g., text documents, graphs, video) via email with the manuscript. If accepted, production staff will create a URL for the SDC file to be placed in a call-out in the article. Files up to 10 MBs are permissible (query managing editor for larger files). For available file types and detailed instructions, see <http://links.lww.com/A142>. Cite SDC consecutively in the text in parentheses, with sequential list number, type of material, and description of content. Include all descriptive text in the call-out as it will not appear elsewhere in the article. Example: "We performed many tests on degrees of flexibility in the elbow (see Video, Supplemental Digital Content 1, which demonstrates elbow flexibility) and found our results inconclusive." Include a list of SDC including number and file type at the end of the manuscript for use by our production staff (list will not be published).

Style: Use *Stedman's Medical Dictionary* (28th edition) and *Merriam Webster's Collegiate Dictionary* (11th edition) as standard references. Refer to medications by generic or chemical names with trade names in parentheses at first mention. To comply with trademark law, include name and location (city/state in US and city/ country outside US) of manufacturer of any drug, supply, or equipment mentioned in the manuscript. Use metric system for units of measure and degrees Celsius for temperatures; use SI rather than conventional units.

AFTER ACCEPTANCE

Compliance with NIH and Other Research Funding Agency

Accessibility Requirements: A number of research funding agencies now require or request authors to submit the post-print (the article after peer review and acceptance but not the final published article) to a repository that is accessible online by all without charge. As a service to our authors, LWW will identify to the National Library of Medicine (NLM) articles that require deposit and will transmit the post-print of an article based on research funded in whole or in part by the National Institutes of Health, Wellcome Trust, Howard Hughes Medical Institute, or other funding agencies to PubMed Central. The revised Copyright Transfer Agreement provides the mechanism.

Copyright: All authors must sign a copy of the journal's "Authorship Responsibility, Financial Disclosure, and Copyright Transfer" form.

Page proofs and corrections: Corresponding authors will receive a pdf of the page proofs to review before publication. It is the author's responsibility to ensure that there are no errors in the proofs.

Reprints: Authors receive a reprint order form/price list when page proofs are prepared which they can fax or mail to Lippincott Williams & Wilkins, Author Reprint Department, 351 West Camden Street, Baltimore, MD 21201. Fax: 410-528-4434. Rapid Ordering can be accessed at <http://www.lww.com/periodicals/author-reprints>. A confirmation of your order will be e-mailed to you. Reprints are normally shipped 6 to 8 weeks after publication of the issue in which the item appears. Contact the Author Reprint Department with any questions.

CONDITIONS OF SUBMISSION

RETAINED RIGHTS: Except for copyright, other proprietary rights related to the Work (e.g., patent or other rights to any process or procedure) shall be retained by the authors. To reproduce any text, figures, tables, or illustrations from this Work in future works of their own, the authors must obtain written permission from Lippincott Williams & Wilkins (LWW); such permission cannot be unreasonably withheld by LWW.

ORIGINALITY: Each author warrants that his or her submission to the Work is original and that he or she has full power to enter into this agreement. Neither this Work nor a similar work has been published nor shall be submitted for publication elsewhere while under consideration by this Publication.

AUTHORSHIP RESPONSIBILITY: Each author warrants that he or she has participated sufficiently in the intellectual content, the analysis of data, if applicable, and the writing of the Work to take public responsibility for it. Each has reviewed the final version of the Work, believes it represents valid work, and approves it for publication. Moreover, should the editors of the Publication request the data upon which the work is based, they shall produce it.

DISCLAIMER: Each author warrants that this Work shall not violate any trademark registrations nor the right of privacy of any person, contains no libelous, obscene, or other unlawful matter, and does not infringe upon the statutory or common law copyright or any other right of any person or party. If excerpts (e.g., text, figures, tables, illustrations, or audio/video files) from copyrighted works are included, a written release will be secured by the authors prior to submission, and credit to the original publication will be properly acknowledged. Each author further warrants that (i) he or she has obtained, prior to submission, valid written releases from all patients whose names, photographs or other protected health information are submitted as part of the Work and (ii) he or she shall maintain such releases and inform LWW in a timely manner of any revocation by a patient of such a release.

PREPRINTS: Upon acceptance of the article for publication, each author warrants that he/she will promptly remove any prior versions of this work (normally a preprint) that may have been posted to an electronic server.

TRANSFER OF COPYRIGHT

AUTHOR(S) POSTING OF ARTICLES TO AN INSTITUTIONAL REPOSITORY

Journal of Psychiatric Practice will permit the author(s) to deposit for display a "post-print" (the final manuscript after peer-review and acceptance for publication but prior to the publisher's copyediting, design, formatting, and other services) 12 months after publication of the final article on his/her personal web site, university's institutional repository or employer's intranet, subject to the following:

- You may only deposit the post-print.
- You may not update the post-print text or replace it with a proof or with the final published version.
- You may not include the post-print or any other version of the article in any commercial site or in any repository owned or operated by any third party. For authors of articles based on research funded by NIH, Wellcome Trust, HHMI, or other funding agency, see below for the services that LWW will provide on your behalf to comply with "Public Access Policy" guidelines.
- You may not display the post-print until 12 months after publication of the final article.
- You must attach the following notice to the post-print: "This is a non-final version of an article published in final form in Journal of Psychiatric Practice (provide complete journal citation)".
- You shall provide a link in the post-print to the Journal of Psychiatric Practice's website (www.psychiatricpractice.com).

COMPLIANCE WITH NIH AND OTHER RESEARCH FUNDING AGENCY ACCESSIBILITY REQUIREMENTS

A number of research funding agencies now require or request authors to submit the post-print (the article after peer review and acceptance but not the final published article) to a repository that is accessible online by all without charge. Within medical research, three funding agencies in particular have announced such policies:

- The U.S. National Institutes of Health (NIH) requires authors to deposit post-prints based on NIH-funded research in its repository PubMed Central (PMC) within 12 months after publication of the final article in the journal.
- The Howard Hughes Medical Institute (HHMI) requires as a condition of research grants, deposit in PMC, but in its case within 6 months after publication of the final article.
- The Wellcome Trust requires, as a condition of research grants, deposit in UK PubMed Central within 6 months after publication of the final article.

As a service to our authors, LWW will identify to National Library of Medicine (NLM) articles that require deposit. This Copyright Transfer Agreement provides the mechanism for identifying such articles. LWW will transmit the post-print of an article based on research funded in whole or in part by one or more of these three agencies to Pub Med Central.

Upon NIH request, it remains the legal responsibility of the author(s) to confirm with NIH the provenance of their manuscript for purposes of deposit.

Author(s) will not deposit their articles themselves.

Author(s) will not alter the post-print already transmitted to NIH.

Author(s) will not authorize the display of the post-print prior to:

- (a) 12 months following publication of the final article, in the case of NIH,
- (b) 6 months following publication of the final article, in the case of Wellcome Trust and HHMI
