Authors wishing to include figures or text passages that have already been published elsewhere are required to obtain permission from the copyright owner(s) and to include evidence that such permission has been granted when submitting their papers. Any material received without such evidence will be assumed to originate from the authors.

Manuscripts must be accompanied by the "Copyright Transfer Statement".

The form is regularly published in this journal or can be obtained from springeronline.com/journal/348.

Please include at the end of the acknowledgements a declaration that the experiments comply with the current laws of the country in which they were performed.

The editors reserve the right to reject manuscripts that do not comply with the above-mentioned requirements. The author will be held responsible for false statements or failure to fulfill the above-mentioned requirements.

2 Editorial procedure

Authors should submit their manuscripts to Experiments in Fluids online to facilitate even quicker and more efficient processing. Electronic submission substantially reduces the editorial processing and reviewing times and shortens overall publication times. Please log directly onto the site <http://expfluids.manuscriptcentral.com> and upload your manuscript following the on-screen instructions.

3 Manuscript preparation

To help you prepare your manuscript, Springer offers a template that can be used with Winword and Word for Macintosh. The word template is available at springeronline.com. Manuscripts written in LaTeX for which Springer offers the macropackage LaTeX2e document class svjour. The macropackage LaTeX2e also is available at springeronline.com/journal/348. For details see point 4.

Manuscripts should be typed in double-line spacing throughout and with at least 2.5 cm (1 inch) margins.

Manuscripts should not exceed 24 double-spaced typewritten pages including figures, tables, illustrations, and the reference list. Short communications must not exceed 1000 words and may not contain more than

two figures. The numbering of chapters should be in decimal form. E.g., 1 Introduction, 2 Experiments, 2.1 Experimental methods, 2.2 Test conditions, etc.

All manuscripts are subject to copy editing.

Title page

- A concise and informative title
- The name(s) of the author(s)
- The affiliation(s) and address(es) of the author(s)
- The e-mail address, telephone and fax numbers of the communicating author

▪ **Abstract** Should precede the main text. It should not exceed 100 words (50 words for a short communication) and must be divided into the following sections:

- 1) Objective – give hypothesis being tested
- 2) Materials and methods - brief but specific to number of subjects, how collected and what was done
- 3) Results – the findings of the study with statistical significance
- 4) Conclusion

▪ A list of **symbols** should follow the abstract if such a list is needed.

▪ **SI units** should be used throughout except where non-SI units are more common [e.g. litre (l) for volume].

▪ The **Introduction** should state the purpose of the investigation and give a short review of the pertinent literature.

▪ The **Materials and methods** section should follow the Introduction and should provide enough information to permit repetition of the experimental work.

▪ The **Discussion** should be an interpretation of the results and their significance with reference to work by other authors.

▪ **Acknowledgements** These should be as brief as possible. Any grant that requires acknowledgement should be mentioned. The names of funding organizations should be written in full.

▪ **Appendix** If there is more than one appendix, they should be numbered consecutively. Equations in appendices should be designated differently from those in the main body of the paper, e.g. (A1), (A2) etc. In each appendix equations should be numbered separately.

References

References will be listed at the end of the paper in alphabetical order of the authors. This list must only include publications which are referred to in the text. The references should appear in the text by referring to the name of the author and the year of publication (in parentheses), e.g. Miller (1979), Miller and Smith (1978) if the

publication has two authors, but: Miller et al. (1977) if the publication has more than two authors.

References to journal articles (abbreviations as in the "Bibliographic Guide for Editors and Authors", published by the American Chemical Society) should appear in the form: 1. names of all authors (initials of the first names behind the family name), 2. year of publication, 3. title of the article, 4. abbreviated title of journal, 5. number of volume, 6. page numbers, e.g., Cross MC, Hohenberg PE (1993) Pattern formation outside of equilibrium. *Rev Mod Phys* 65:851–1112

References to books should appear in the form: 1. names of all authors (initials of first names behind the family name), 2. year of publication, 3. complete title of the book (including volume number, part number, page numbers if necessary), 4. place of publication, 5. name of the publisher, e.g., Rodi W (1975) A review of experimental data of uniform density free turbulent boundary layers. In: *Studies in convection*. (ed Launder, B E). Vol. 1, pp 79-166, London: Academic Press

References such as "personal communications" or "unpublished data" cannot be included in the reference list, but should be mentioned in the text in parentheses: this also applies to papers presented at meetings but not yet published or accepted for publication. A date should be given for both "personal communications" and "unpublished data".

Papers which have been accepted for publication should be included in the list of references with the name of the journal and "in press".

If available the **Digital Object Identifier (DOI)** of the cited literature should be added at the end of the reference in question.

Illustrations and Tables

All figures (photographs, graphs or diagrams) and tables should be cited in the text, each numbered consecutively throughout. For color illustrations the authors will be expected to make a contribution (EUR 485, US \$ 534, plus 16% VAT) towards the extra costs, irrespective of the number of color figures.

Tables

Tables should have a title above and, if needed, a legend at the bottom explaining any abbreviations used. Footnotes to tables should be indicated by superscript lower-case letters or asterisks for significance values and other statistical data. (see also General layout guidelines).

Illustrations

Illustrations should be prepared in electronic form whenever possible; non-digital originals should be scanned and vector graphics used. All figures (photographs, graphs or diagrams) should be cited in the text and figure parts should be identified by lower-case roman letters. Figure legends must be brief, self-sufficient explanations of the illustrations.

Electronic Formats

Scan resolution: Scanned line drawings should be digitized with a minimum resolution of 600 dpi relative to the final figure size. For digital halftones, 300 dpi is usually sufficient.

Color illustrations: Store color illustrations as RGB (8 bits per channel) in TIFF format.

Vector graphics: Fonts used in the vector graphics must be included. Do not draw with hairlines. The minimum line width is 0.2 mm (i.e., 0.567 pt) relative to the final size. Vector graphics exported from a drawing program should be stored in EPS format; the EPS file must always contain a preview in TIFF of the figure. Suitable drawing programs include Freehand, Illustrator, Corel Draw, and Designer.

Raster graphics: Suitable image-processing programs include Photoshop, Picture Publisher, Photo Paint, and Paint Shop Pro. Most presentation programs, such as Excel, Power Point, and Freelance, produce data that cannot be processed for publication, because they do not support the export of EPS data. Use patterns instead of colors to fill graphics, because monotone reproduction merges colors into gray tones.

General Formats

Plates: Several figures or figure parts may be grouped in a plate on one page, with maximum display area for figures and captions of 17.6×23.6 cm.

Size of figures: The figures should either match the width of the column (8.6 cm) or be 13.1 cm or 17.6 cm wide. The maximum length is 23.6 cm.

Lettering: Because illustrations are usually reduced in size for publication, lettering must be large enough to permit reduction of up to 30%.

4 Electronic submission of final version

At the time that an Editor notifies an author of acceptance of a manuscript for publication, the author will receive instructions on submitting the final manuscript online in electronic form.

Please send only the final version of the article, as accepted by the editors.

Preparation of final manuscript

Submit the final manuscript online. After final acceptance of your manuscript for

publication, submit a separate file for the text (with tables and figure legends included) and a separate file for each figure. The file name (one file for each figure) should include the figure number.

File format:

The text file types preferred are the following:

- .doc
- .rtf

The graphics file types allowed include only the following:

- .tif
- .eps
- .pdf

This journal accepts either LaTeX or Word documents.

LaTeX: The electronic version should include the original source (including all style files and figures) and a PostScript version of the compiled submission. Authors who prepare their papers with LaTeX are encouraged to use Springer's macro package *svjour* for this journal, available at springeronline.com/journal/348.

How to create TIF or EPS files?

To create graphics, please use a standard graphics programme. The menus of the programmes are all similar. Please use the export function (TIF or EPS) to save your files. EPS is best used for diagrams or graphics with a large proportion of text. Please proceed as follows:

Creating an EPS file:

1. Mark the whole figure (include all elements)
2. Menu Arrange/Order - Group
3. Menu File - Export - Select the right file extension EPS (for encapsulated postscript)
4. Insert the name of the figure in the field
5. Click on: only marked objects
6. Click button: Export
7. Click on: Text to curves/lines (to avoid conflicts in typstyles for the further process)
8. Click on: Preview
9. To transmit the bitmap: click on grayscale if you do not want the figure to be in colour or on RGB 8 bit for colour figures
10. (not available in all programmes: use the standard resolution (300 dpi) prescribed by the programme)

Please note: EPS files must always contain a preview of the figure in TIF.

Creating a TIF file (for halftone illustrations: photographs, photographs combined with line drawings, photographs with labelling):

1. Mark the whole figure (include all elements)
2. Menu Arrange/Order - Group
3. Menu File - Export - select the right file extension (TIF for TIF- Bitmap)
4. Choose compression (LZW)
5. Insert the name of the figure in the field
6. Click on: only marked objects
7. Click button: Export
8. Choose colour mode (for colour figures: RGB 24 bit; for black and white photos: greyscale 8 bits; for black and white drawings: black and white)
9. Click: OK

5 Electronic supplementary material

Electronic supplementary material (ESM) for an article in the journal will be published in SpringerLink provided the material is:

- submitted to the Editor(s) in electronic form together with the paper and is subject to peer review.
- accepted by the journals Editor(s).

ESM may consist of

- information that cannot be printed: animations, video clips, sound recordings.
- information that is more convenient in electronic form; sequences, spectral data, etc.
- large original data that relate to the paper, e.g. additional tables, illustrations (colour and black & white), etc.

After acceptance by the journals Editor(s) ESM will be published as received from the author in the online version only.

Reference will be given in the printed version.

6 Proofreading

Authors should make their proof corrections on a printout of the pdf file supplied, checking that the text is complete and that all figures and tables are included. After online publication, further changes can only be made in the form of an Erratum, which will be hyperlinked to the article. The author is entitled to formal corrections only. Substantial changes in content, e.g. new results, corrected values, title and authorship are not allowed without the approval of the responsible editor. In such a case please contact the Editor before returning the proofs to the publisher.

50 offprints of each contribution are supplied free of charge. If you wish to order additional offprints you must return the order form with the corrected proofs. You are then entitled to receive a pdf file of your article for your own personal use.
