

How to Publish an Article in the Journal *Instruments and Experimental Techniques*

The journal is published in Russian and translated into English. The journal is international: papers in Russian can be submitted by authors from any country. Publication is free. The order of publication of articles is determined by their readiness for printing. Articles prepared thoroughly in full agreement with the **“Rules for Preparing Articles”** and **“Recommendation to Authors for Preparing Articles for Publication”** (see *Prib. Tekh. Eksp.*, 2001, no. 1), prompting no editor’s questions and needing no refinement and corrections will be published earlier than those needing corrections.

For articles to be published, the authors must send
their consent for author’s rights transfer
in the following form:

Copyrights transfer agreement. We, the undersigned, authors of the manuscript _____
_____ transfer the publishing rights
for this manuscript in Russian and the English translation to the founders and editorial board of the journal *Instruments and Experimental Techniques* (IET). We confirm that this publication does not violate the author’s rights of other persons or organizations.

This agreement does not prevent the authors from individually using the Russian and English versions of their paper for noncommercial purposes and preserves all of their rights as proprietors of this manuscript, including the right to check and correct the translation before its publication.

This agreement is valid for three years.

Taking into account the stringent terms of the work with a manuscript, we agree to the following (underline one of the variants):

(1) we ask to be informed by telephone, no. _____, and our representative will report to the editorial office to correct the translation;

(2) we guarantee that, within three days from the moment the translation proof is received, we shall send it back; if there are no or a few corrections, we shall promptly inform the editorial board by telephone;

(3) we agree to the publication of the English version of our manuscript without preliminary checking.

We are warned that, if the proof is returned with a delay (including cases of mail delivery delays), the manuscript may be published in English in the initial form received from the translator.

THE MAIN REQUIREMENTS TO THE PAPER’S SUBJECT MATTER

1. The subject of an article must have specific applications to experiments that employ the physics methods described and illustrated in the article.

2. The device or method described must be implemented and tested in an experiment that has shown advantages over existing devices and methods, and these advantages must be distinctly expounded in the paper.

3. A review must be written in sufficient detail to make it clear for physicists of any speciality. It is desirable for a review to have a brief introduction elucidating the main problems, notions, and terms.

4. The article must be complete enough and have the necessary details to enable a qualified reader to reproduce the method and instrument which were implemented and tested, taking into account the references cited. This requirement also refers to deposited papers and preprints whose brief subject matters are published in IET. The summary of an article deposited upon presentation by IET must give a clear idea of the objective of the study, principle of a method, performance characteristics, measurement errors, the possibilities and features of the device application.

5. Comments and the author's answers should be concerned only with the essence of the discussed paper: physical errors, inaccuracies, mentioning of better alternative designs and approaches.

6. Brief information on a new instrument or material manufactured in a laboratory must contain its name and basic technical and performance characteristics. The information on a device can be supplemented by photographs in the operating state, and a photograph of a material is accepted only if it gives a clear idea of its properties. A second figure—a plot or diagram characterizing the capabilities of the device—is permissible. An address should be provided in case of an inquiry to the authors for additional information.

7. The size of the reviews and original papers submitted for publication in the journal is not formally limited. The maximum sizes of other materials are as follows: summaries of deposited papers and preprints, 6 pages and 3 figures; comments and answers, 2 pages and 1 figure; brief information on instruments manufactured in laboratories, 2 pages and 1 figure; advertisements, 1 page and 1 figure per each paid page. The text is typed with double line spacing in standard types.

The size of deposited papers is not limited. See the rules in "Instruction to the Order of Depositing Manuscripts on Natural, Technical, and Social Sciences," Moscow: VINITI, 1977.

8. A review, an article, or a summary of a deposited paper, or a preprint must be preceded by a short (10–15 lines) presentation of their essence (abstract) clearly defining the novelty of the subject and presenting its numerical characteristics (errors, sensitivity, etc.). The abstract should have as large a body of information as possible and be understandable independently of the article, since each IET issue publishes abstracts of the papers assigned for publication in subsequent issues.

OBLIGATORY ORDER OF PREPARATION OF THE SUBMITTED MATERIALS

1. The paper must be signed by each author. Papers based on studies carried out at an institute should carry the exact name and address of the institute, which are published in the paper. The original names and addresses of foreign institutes should be given in Latin characters. Commercial advertisements are published, provided payment fixed by an agreement is guaranteed.

2. Papers (except for those intended for publication in the section "Instruments Manufactured in Laboratories" and commercial advertisement) must be accompanied by an agreement to the transfer of copyrights for the Russian and English translation versions.

3. Papers should be written in a condensed form, consistent, with completeness of presentation and be fully ready for publication.

4. Papers should be printed in double spacing in standard types on one side of white sheets of papers and submitted in two legible copies (one of them must be the original copy) without, if possible, smudges and casing-ins; color and thin papers are prohibitive; no abbreviations of words, except for conventional ones, are allowable. All pages of a manuscript must be numbered. A paper must be signed by the author (all of them, if there are several authors). An electronic version of the submitted paper is desirable in addition.

5. Formulas must be written clearly with ink. Special attention should be paid to the notation of subscripts (lowering with an arc) and indices of powers and superscripts (lifting with an arc).

In order to avoid mistakes, it is necessary to distinguish between lower case and capital letters in formulas. When capital and lower case letters differ only by their size (V and v , U and u , W and w , K and k , S and s , C and c , P and p), lower case letters must be marked with two lines on their top (e.g., $\bar{\bar{s}}$), and capital letters must be underlined by two lines (e.g., $\underline{\underline{S}}$). It is necessary to distinguish between the letters O (capital) and o (lower case) and 0 (zero): the letters are marked in the aforementioned manner, and zero is not marked. It is necessary to discriminate between the letters J and I : I is written as the Roman "one." Greek letters must be underlined with a red pencil and vectors with a blue pencil (without arrows on the top).

If formulas are typed by using computer printing, their marking-out is unnecessary (except for the underlining of vectors).

6. Footnotes must have common numbering throughout the paper.

7. References are given as a common list at the end of an article and are denoted in the text by an ordinal in square brackets (e.g., [1]). The cited papers must have the following form:

(a) for journal articles: the surnames and initials of the authors, journal title, year, number, and page must be given;

(b) for books, the surnames and initials of the authors, full title of the cited book, publisher, city of publication, year, page (for foreign books, the reference to the Russian translation must be given, if it exists);

(c) for collections and proceedings of conferences, the surnames and initials of the authors, title of the collection (conference), city and publisher (institute), year, volume, number, and page.

If the number of authors does not exceed four, all of them should be mentioned. In the opposite case, the surnames and initials of the first three authors should be given.

8. Commercial devices and materials mentioned in articles must be referred to by their catalog name; their types, brands, and names of the companies that produce them must be given.

9. Figures and drawings should be submitted separately from the manuscript and carry figure captions on a separate sheet. The title of the article, names of the authors, and figure numbers must be written (with a pencil) on the back sides of figures. The figures' quality must allow for reproduction in the journal in the presented form.

10. Drawings, diagrams, and plots must have a format ensuring clear understanding of all details; this is especially important when drawings are replaced by photocopies. Figures must be compact in order to save space. Bear in mind that figures with a width of ~8 cm (one column), ~17 cm (two columns), and a size of 17×23 cm (the entire page) are most convenient for printing. Thus, it is desirable to draw elements and inscriptions so that, when scaling a figure to one of these dimensions, letters and numbers are 1.5–2 mm high, circuit elements are 3–5 mm high, individual dots have a size of 1 mm, and lines are separated by spacings of at least 0.5–1 mm.

The values of circuit components must be written directly on diagrams (e.g., 1Ω ; 5.6 k Ω ; 2 M Ω ; 1 G Ω ; 15 pF; 2.2 nF; 1.0 μ F). Circuit components should be imaged with conventional signs. All figures should be thoroughly checked.

11. Photographs of the most interesting details or general views of the described devices should be made on glazed paper in a 9×12 -cm² format (three copies; two versions are preferable, bearing in mind the possibility of the picture being on the journal cover) and have high quality. Photos taken on experimental setups (oscillograms, tracks in chambers, microphotograms, etc.) should also be made on glazed paper and submitted in three copies.

12. For the authors published mainly in English, original names in Latin letters should be given. An article should be supplemented with a list of specific terms and materials and their conventional English translations. Foreign analogs of Russian materials and devices should be given, if possible. The authors' versions of the translation of the title and abstract, name of the institute sending the paper, and authors' names written in Latin letters should also be submitted.

13. When the editorial board sends an article to the author for correction and refinement, the author has two months for this procedure, after which the returned paper is considered a new one.

14. The editorial board sends one copy of the article layout prepared for publication to the author for correction. The authors residing in Moscow check their papers at the editorial office. The corrected paper signed by the authors should be sent back to the editorial board within three days from its receipt. If there are a few simple corrections or they are altogether absent, it is desirable to inform the editorial board by telephone. This may speed up the publication of the article.

15. The exact address, surname, initials, telephone (home and office), fax, and e-mail address must be appended to the manuscript.

16. An electronic version of the article (3.5" or 5" floppy disks), which must be identical to the print version, is submitted together with the paper.

The electronic version should constitute a file with the text and files with figures. IBM PC formatting is desirable. If the text and figures are represented in a single file, additional files with figures are required. In order to avoid malfunctions, the written files should be tested.

A set of files must be accompanied by a list (or a file) where the following information is available: disk format, operating system, name of the text editor, names of the files, titles of the journal and articles, surname and initials of the author (authors).

When sending files via e-mail, the following rules should be observed:

– the number of the journal and author's name should be given in the section "subject";

– it is desirable to use "attach";

– if the body of information is large, one may use well-known archives

(ARJ, ZIP, RAR, etc.); UU-coding is desirable for reliable data transfer.

17. It is desirable to present the text of the article in the Text-Only format. Pay attention to the fact that lines within a paragraph should not be divided by using the *Enter* key; otherwise, such texts cannot be utilized.

Papers can be presented in MicrosoftWord 2-7 or TEX formats; then, the subset and version of the publishing system should be mentioned.

18. Scanned and computer-drawn black-and-white figures are accepted in electronic versions.

Graphics files must be denoted unambiguously (the title of the article and the figure number). Each file must contain a single figure.

When preparing graphics files, the following rules should be observed:

(1) It is desirable to use the TIFF format (JPEG and GIF are also acceptable) for half-tone photos and hatched drawings.

(2) The EPS and PS formats are recommended for vector figures and diagrams (figures prepared in programs of vector graphics).

When submitting files in the TIFF format, it is desirable to observe the following rules: 600 dpi (dots per inch) for scanned hatched drawings and at least 200 dpi for scanned half-tone drawings and photographs.
