Instructions for Authors (updated 11.9.03)

Introduction

It is essential that authors prepare their manuscripts according to established specifications. The effectiveness of the search capabilities offered by electronic delivery will depend upon the care used by authors in preparing their manuscripts. Therefore, contributors are strongly encouraged to read these instructions carefully before preparing a manuscript for submission, and to check the manuscript for compliance with these notes before submitting it for publication.

Papers submitted for consideration should be sent to the editor, Richard G. Krutchkoff, either by email (<mailto:JSCS@vt.edu>) or regular mail (*Journal of Statistical Computation and Simulation*, PO Box 10728, Blacksburg VA, 24062 0728, USA)

Email is the preferred method. Each submission must be accompanied by a cover letter containing the corresponding author's name, postal address and email address, the title of the paper and the names of all co-authors. This letter may be in text in the email itself or in an attachment to the email in MS WORD, PDF or POSTSCRIPT format. The paper should be in an attachment in one of these three formats. Papers sent by regular mail can be in hard copy format but a disk (floppy or CD) is preferred.

Typescripts

Journal of Statistical Computation and Simulation is a peer-reviewed journal. Submission of a paper to this journal will be taken to imply that it represents original work not previously published, that it is not being considered for publication elsewhere, and that if accepted for publication it will not be published elsewhere in the same form, in any language, without the consent of the editors and publisher.

Abstract: Each paper should contain a leading abstract of not more than 400 words, with as few mathematical formulae as possible. This abstract will also appear in Statistical Theory and Method Abstracts, edited by the International Statistical Institute.

Keywords: Please include several keywords for your paper. They should be so headed and typed below the abstract.

Figures

All figures should be numbered with descriptive captions and be mentioned in the text. An approximate position for each figure should be indicated in the text.

Preparation: Figures submitted must be of a high enough standard for direct reproduction. Each figure should be clearly labelled with a figure number and description. Redrawing or retouching of unusable figures will be charged to the authors.

Captions: A list of figure captions should be on a separate page and included with the typescript.

Color Pages: There are a limited number of color pages within the annual page allowance. However, authors should restrict their use of color to situations where it is necessary on scientific, and not merely cosmetic, grounds. In addition, authors may pay to publish color illustrations, but please consult the publisher regarding cost before submission.

Tables

Number tables consistently and give each a clear, descriptive caption. Whenever possible, avoid the use of vertical rules in tables.

References and Notes

References and notes are indicated in the text by the Harvard (name and date) system; for example "Recent work (Smith, 1970)...". The full list of references should be collected and typed at the end of the paper in alphabetical order. Listed references should be complete in all details, including article titles. Journal title abbreviations should follow the style of Mathematical Reviews. The initials of the first-named author should be placed after his name; the publication's year follows the last-named author.

Footnotes

Authors are encouraged to minimize the use of footnotes. A footnote may include the designation of a corresponding author of the paper, current address information for an author (if different from that shown in the affiliation), and traditional footnote content. Information concerning grant support of research should appear in a separate Acknowledgements section at the end of the paper, not in a footnote. Acknowledgement of the assistance of colleagues or similar notes of appreciation also properly belong in an acknowledgements section, not in footnotes.

Tutorials

Well-written and up-to-date tutorials on subjects of interest to our readers are welcome. Tutorials are not required to contain original research. Send typescripts directly to the editor, Richard G. Krutchkoff, in the same format as above, noting in the cover letter that the typescript is a tutorial.

Comments, Conjectures, and Conclusions

A heading is not required, but if there is one it should be entirely in capitals and should be two spaces above the text. The author's name should be placed at the foot, two lines below the text, followed (one line below) by his affiliation. The References should be so headed. An Abstract is not required. No reprints will be supplied for items in this section. In a covering letter please mention whether you have other relevant publishing intentions. Also please submit your relevant reprints and neat rough work.

Good grammar is essential. For example, the expression "this is denoted y " would lead to the return of the typescript. Foreign-speaking authors should seek advice where necessary, especially regarding the use of the definite article.

Simulations

The results of simulation studies, both positive and negative, which are not sufficient to warrant a long paper, should be summarized and submitted to the Comments, Conjectures, and Conclusions section (see above). A paper of more than three typewritten pages, however, should be submitted as a research paper.

Book Reviews

Books for review should be sent directly to the book review editor, Ram Shanmugam, Department of Health Services & Research, Southwest Texas State University, 601 University Drive, San Marcos, Texas 78666-4615, USA.

Proofs

Authors will receive page proofs (including figures) by air mail or email for correction, which must be returned to the typesetter within 48 hours of receipt. Please ensure that a full postal address, plus phone, fax and email details where available, are given on the first page of the typescript, so that proofs are not delayed in the post. Authors' alterations in excess of 10% of the original composition cost will be charged to authors.

Page Charges

There are no page charges to individuals or institutions.

Offprints

Corresponding authors can now receive their article by e-mail as a complete PDF. This allows the author to print up to 50 copies, free of charge, and disseminate them to colleagues. In many cases this facility will be available up to two weeks prior to publication. Or, alternatively, corresponding authors will receive the traditional 50 offprints. A copy of the journal will be sent by post to all corresponding authors after publication. Additional copies of the journal can be purchased at the author's preferential rate of £15.00/\$25.00 per copy.

It is a condition that authors vest copyright in their articles, including abstracts, in Taylor & Francis Ltd. This enables us to ensure full copyright protection and to disseminate the article, and the journal, to the widest possible readership in print and electronic formats as appropriate. Authors may use their article elsewhere after publication provided that prior permission is obtained from Taylor & Francis Ltd. Authors are themselves responsible for obtaining permission to reproduce copyright material from other sources.
