

Instructions for Authors

The **Journal of Comparative Physiology A** publishes original articles in general and comparative animal physiology. Preliminary communications will not be considered.

Submission of a manuscript implies that it has not been published and will not simultaneously be submitted elsewhere. Before submission, the principal author must obtain the consent of the author's institution, the co-authors and co-workers.

All manuscripts are subject to peer review, and to language- and copy-editing after acceptance.

Manuscripts must be accompanied by the "Copyright Transfer Statement" (the form is regularly published in this journal).

The author(s) transfer(s) the copyright to his/her article to Springer-Verlag effective if and when the article is accepted for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form): it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable. The author will receive page proofs; changes introduced at this stage will be charged to the author.

There are no page charges.

Offprints. Thirty (30) offprints are provided free of charge for each paper. Orders for offprints can be placed by returning the order form with the corrected proofs. When you order offprints, you are entitled to receive in addition a pdf file of your article for your own personal use.

Neither the editors nor the publisher can assume responsibility if manuscripts or parts of manuscripts are lost.

To save on postage, manuscripts will not be returned, neither for revision nor when rejected, except for those pages carrying important comments from the reviewers and except for original figures.

Manuscripts must be written in English and be submitted in triplicate to the editors (original typed on one side of the paper only plus 2 copies photocopied on both sides). They must be printed double-spaced, with a left-hand margin of at least 4 cm. Genus and species names are to be in italics, but not the common names.

Manuscripts in electronic form. Authors are strongly encouraged to send the final version of their manuscript - after acceptance for publication - in electronic form. Please follow the special technical instructions as printed in most issues of this journal.

Rapid communications are a special category of article for quickly reporting significant, original findings by means of an expedited review and production schedule. Authors wishing to submit a rapid communication should send the title page and abstract by fax or courier service to the Editor responsible for their geographical area with a cover note requesting that the paper be handled as a rapid communication. The Editor will immediately inform the author whether or not the journal can review the manuscript in this way. Manuscripts being considered for rapid publication receive special, expedited review and, if accepted, are assigned a priority position in printing and production so that they can be published within 3 months of acceptance. Papers for this section must not exceed 4 printed

pages including references, illustrations, and tables. The abstract must not be longer than 100 words. (An average printed page includes approximately 6200 characters including spaces, or circa 1000 words. Please do not forget to add the space for illustrations and tables when you calculate the length of your paper.) The final accepted version must be submitted to the publisher on diskette or via ftp (ftp.springer.de).

Manuscripts are to be arranged in the following sequence: title page, abstract, 5 keywords, introduction, materials and methods, results, discussion (for short papers, the latter two sections may be combined), acknowledgements, references, figure captions, tables, illustrations. Pages should be numbered consecutively throughout, beginning with the title page. Authors should consult a recent paper in the journal to ascertain general manuscript requirements.

The first page of a manuscript should provide: title, name(s) of author(s), full departmental and institutional affiliation, footnotes to the title page (including an alphabetical list of abbreviations), address for correspondence (including fax number and e-mail address).

Abstract. Only the main results should be summarized without giving references or abbreviations. The abstract must comprise a maximum of 200 words.

Text. Lengthy introductions should be avoided, and the subject should be approached in a straightforward manner. Except for well-known methods, experimental methods should be explained in sufficient detail.

Footnotes are to be numbered consecutively throughout the text with superscript Arabic numerals.

Please include at the end of the acknowledgements a declaration that the experiments comply with the current laws of the country in which the experiments were performed.

Units, symbols, abbreviations. SI units and the conventions of the International Union of Pure and Applied Chemistry (IUPAC) are recommended: except for thermodynamics, the Celsius temperature scale should be used. Abbreviations must be kept to a minimum; ad hoc abbreviations should be avoided. Except for standard physiological and biochemical abbreviations (R.Q., e.p.s.p., STDP, ATP, NAD, EDTA, etc.), all abbreviations must be explained in a footnote on the title page.

References. Citations in the text should be made as follows "...Schmidt (1965) found..." or "...observed (Schmidt 1965; Granhuis and Klahr 1970 a,b; Richards et al. 1968)...". The list of references should be in alphabetical order in accordance with these examples:

Winfree AT (1980) *The geometry of biological time*. Springer, Berlin Heidelberg New York

Tables. Each table must be typed on separate sheet together with its heading, and ample space should be allowed for editorial comments.

Figures. Illustrations should be limited to truly essential material, which clarifies the text. Repetition of the same data in both the figures and the tables must be avoided. All figures must be numbered consecutively and submitted on separate sheets.

Line drawings are to be submitted as good-quality prints or computer drawings of the same quality. Final height of lettering (after reproduction) should be about 2 mm: original drawings should not exceed the print area (176 × 236 mm).

Photographs and electron micrographs should be well-contrasted, sharp prints on glossy paper, trimmed at right angles. Transparent overlays with the required lettering may be provided. Micrographs should contain a bar marking the scale.

For color illustrations the authors will be expected to make a contribution (€ 485 US\$ 475 plus 16% VAT) towards the extra costs, irrespective of the number of color figures. The cost for a limited number of color articles per issue may be waived at the discretion of the Chief Editor.

Figure legends must be typed consecutively, starting on a separate sheet, and placed after the reference section.

Illustrations prepared in digital form must be in accordance with the technical instructions for manuscripts and illustrations in electronic form that are published in this journal.

Electronic supplementary material. Data such as black and white or colour illustrations, large tables, animations, video clips, or sound recordings, that are not essential for the understanding of a printed article but yet of interest can be put on Springer-Verlag's server and will be accessible free of charge on the contents site of this journal. Such material has to be submitted in electronic form (see the special instructions that are regularly published in this journal) and will also be reviewed. Reference to this material will be given with the printed article.
