

Information for Authors

The JOURNAL OF MICROELECTROMECHANICAL SYSTEMS (JMEMS) is published bimonthly. The topics of interest for JMEMS include, but are not limited to: structures and devices whose largest dimensions are typically measured in micrometers (occasionally, in nanometers or millimeters); micro-sensors and microactuators; microrobotics; microtelemanipulation; fabrication techniques for MEMS structures; interfaces and compatibility issues for microelectronics and micromechanics; measurements, modeling, and theory for microphenomena; microtribology and microfluidics; materials for MEMS devices; standards appropriate to MEMS; and application examples for MEMS in any of a broad range of disciplines.

A. Procedure for Submission of Manuscript

Send four paper copies of the manuscript along with a brief introductory letter (that clearly identifies the corresponding author, preferably stating e-mail, fax, and post-office addresses) to the Editor-in-Chief: Richard S. Muller, BSAC/E ECS #1770, University of California, Berkeley, CA 94720-1770 USA. The submitted copies should include figures, but authors are asked to hold copies of original art work until after the paper has been reviewed and a notice that publication acceptance is recommended has been received by the corresponding author. A Subject Editor, assigned by the Editor-in-Chief, will carry out the paper review in as expeditious a fashion as possible. If the paper is recommended for acceptance, authors will be asked to supply the following material:

- three copies of final manuscript form to the Editor-in-Chief
- signed copyright transfer form to IEEE (Available at <http://www.ieee.org/copyright/>)
- author biography(ies) to IEEE
- author photograph(s) to IEEE
- original art work to IEEE (Art submitted electronically is only acceptable as: TIFF, PostScript, or EPS. Quality hard copies of all graphics must accompany the disk) (See also <http://www.ieee.org/organizations/pubs/transactions/information.htm/>).
- electronic version of final manuscript to IEEE (See G below).

B. Length and Style of Manuscript

- 1) Papers should be a maximum of 12–15 pages in length, double-spaced, typewritten or printed in 11 points or larger, plus up to 10 figures (six or fewer printed journal pages). Longer papers will be accepted if the added length makes a substantial contribution. Papers requiring major revision will be rejected, but if the author is invited by the Editor to resubmit it and the author provides an appropriate revision within six weeks, the paper retains its original submission date.
- 2) The first manuscript page should contain author name(s), affiliation(s), and a corresponding author's address, phone/FAX number, and e-mail address. If the corresponding author will be unavailable for a length of time, please include an alternate contact.
- 3) The paper must be written in correct English and convey ideas of importance to the MEMS community. It should have value both to neophytes and experts in the field. Useful information for authors is collected on the web at <http://www.ieee.org/about/whatis/policies/p6-4.xml>
- 4) Provide a carefully worded abstract (a maximum of roughly 200 words) that answers the following questions. (a) What is the problem or topic discussed, and what is the scope of its treatment? (b) What is the unique approach or important contribution of the paper? (c) What is the solution, conclusion, principal result, or typical application?
- 5) Succeeding pages should contain, in order, the body of the paper, acknowledgments, references, biography, and figure captions on a separate sheet. All pages should be numbered with the first page being the title-abstract page.
- 6) References should be complete and follow IEEE style:
 - Style for Papers:* Author (with initials first), title, journal title, volume number, inclusive page numbers, month, year;
 - Style for Book:* Author, title. Location of publisher: year, page, or chapter number, if desired.
- 7) Please use the International System of Units, the MKS system, except where custom or clarity dictate other units.
- 8) Suggestions on organizing a paper, recommended abbreviations, etc. are contained in "Information for IEEE Transactions and Journal Authors," available from the IEEE Transactions/Journals Department, 445 Hoes Lane, P.O. C. Style for Illustrations

Figures and photos should be original proofs and not photocopies. Photos must be glossy prints with no screens. Laser prints are not acceptable in place of photos or where gray scale graphics are involved. All line drawings and photos should be in black and white, unless color is specifically requested. Letters should be readily legible when the drawing is reduced to a 2 or 1 column width as much as 4:1 reduction from the original. All original materials should be larger than 22 × 28 cm (8 1/2 × 11 in.) Do not import electronic graphics into your paper. If color is to be reproduced, the corresponding author must agree to accept responsibility for payment of the costs for separations and printing before any processing of color graphics is performed. The corresponding author must provide a method of payment as well, either through their organization or credit card. The current costs for color reproduction is a flat printing fee of US\$1045.00 plus US\$125.00 per piece of color artwork. (Please note that this cost does not include the ordering of Reprints.)

D. Page Proofs

Page proofs are sent to the corresponding author immediately prior to publication of the paper. Minor and typographical errors should be noted, corrected, and returned according to the instructions enclosed with the proofs. Major changes to the author's manuscript will not, in general, be permitted.

E. Page Charges

After a manuscript has been accepted for publication, the author's institution will be requested to pay a charge of \$110 U.S. per printed page to cover part of the cost of publication. Page charges for this JOURNAL are not obligatory, nor is their payment a prerequisite for publication. The author will receive 100 free reprints without covers if the charge is honored. Detailed instructions will be provided with the page proofs.

F. Copyright

It is the policy of the IEEE to own the copyright to the technical contributions it publishes on behalf of the interests of the IEEE, its authors, and their employees and to facilitate the appropriate reuse of this material by others. To comply with U.S. Copyright Law, the authors are required to sign and return an IEEE Copyright Form before publication. This form returns to authors and their employees full rights to reuse their material for their own purposes.

G. Electronic Form of Final Manuscript

For the final printed production of the manuscript, the author will need to provide a disk (5 1/4" or 3 1/2") and three paper copies of the peer-approved version. Changes made to paper version must be incorporated into your electronic version and include an ASCII version of the file. Note the operating system (DOS, MAC, UNIX, etc.) and the software used on the label of the disk. Check that your files are complete including: abstract, text, references, footnotes, biographies, figures, and captions. IEEE will accept most commercial software programs. The preferred programs are TeX, LaTeX, and Word (use standard macros). LaTeX style and sample files and a template for Microsoft Word can be found at www.ieee.org/pubs/authors.html/. Notify the editors of any special circumstances, such as pending clearance or previous publication. It is understood that the submitted paper is not simultaneously under consideration by another journal and previously published papers are normally not considered.
