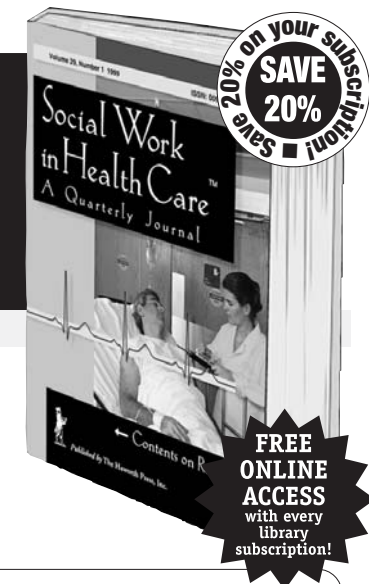

SOCIAL WORK IN HEALTH CARE™—Instructions for Authors

1. ORIGINAL ARTICLES ONLY. Submission of a manuscript to this journal represents a certification on the part of the author(s) that it is an original work, and that neither this manuscript nor a version of it has been published elsewhere nor is being considered for publication elsewhere.

2. MANUSCRIPT LENGTH. Your manuscript should not exceed **25 typed pages** double-spaced (including references and abstract). Lengthier manuscripts may be considered, but only at the discretion of the editor. Sometimes, lengthier manuscripts may be considered if they can be divided up into sections for publication in successive journal issues.

3. MANUSCRIPT STYLE. References, citations, and general style of manuscripts for this Journal should follow the APA style (as outlined in the latest edition of the *Publication Manual* of the American Psychological Association). References should be double-spaced and placed in alphabetical order. The use of footnotes within the text is discouraged. Words should be underlined only when it is intended that they be typeset in italics.

If an author wishes to submit a paper that has been already prepared in another style, he or she may do so. However, if the paper is accepted (with or without reviewer's alterations), the author is fully responsible for retyping the manuscript in the correct style as indicated above. Neither the editor nor the publisher is responsible for re-preparing manuscript copy to adhere to the journal's style.

4. MANUSCRIPT PREPARATION. For efficiency, electronic submissions of manuscripts are encouraged and should be e-mailed to andrew.weissman@msnyuhealth.org or gary.rosenberg@msnyuhealth.org. IBM-compatible programs such as WordPerfect and Microsoft Word are preferred.

Three complete copies of the manuscript with a corresponding disk should be sent to **Dr. Gary Rosenberg, The Mount Sinai Medical Center, One Gustave L. Levy Place, Box 1246, New York, NY 10029**. Manuscripts should be typewritten on standard (8 1/2" X 11") white paper with 1" margins on all sides. The entire manuscript, including references, figures and tables, should be double-spaced and should not exceed **25 pages**. Each element of the manuscript should begin on a new page: title page, abstract, text, references, tables (typed 1 per page), figure legends. Number pages consecutively.

Title Page: The first page of the manuscript should contain the following information:

- (1) the title of the contribution
- (2) the names, titles, and affiliations of each author
- (3) mailing address, phone, fax, and e-mail address of the corresponding author
- (4) acknowledgments for research support
- (5) a short running title of not more than 40 letters and spaces
- (6) three to five key words for indexing purposes

Abstract: Provide an abstract of not more than 250 words, written in full, informative sentences. The abstract should briefly describe the problem being addressed and the hypothesis, how the study was performed, the important findings, and the interpretation of the results.

5. REFERENCE LINKING. The Haworth Press is participating in reference linking for journal articles. (For more information on reference linking initiatives, please consult the CrossRef Web site at www.crossref.org.) When citing a journal article include the article's Digital Object Identifier (DOI), when available, as the last item in the reference. A Digital Object Identifier is a persistent, authoritative, and unique identifier that a publisher assigns to each article. Because of its persistence, DOIs will enable The Haworth Press and other publishers to link to the article referenced, and the link will not break over time. This will be a great resource in scholarly research.

6. RETURN ENVELOPES. When you submit your three manuscript copies, also include:

- a 9" x 12" envelope, self-addressed and stamped (with sufficient postage to ensure return of your manuscript);
- a regular envelope, stamped and self-addressed. This is for the Editor to send you an "acknowledgement of receipt" letter.

7. SPELLING, GRAMMAR, AND PUNCTUATION. You are responsible for preparing manuscript copy which is clearly written in acceptable, scholarly English and which contains no errors of spelling, grammar, or punctuation. Neither the editor nor the publisher is responsible for correcting errors of spelling and grammar. The manuscript, after acceptance by the editor, must be immediately ready for typesetting as it is finally submitted by the author(s). Check your paper for the following common errors:

- dangling modifiers
- misplaced modifiers
- unclear antecedents
- incorrect or inconsistent abbreviations

Also, check the accuracy of all arithmetic calculations, statistics, numerical data, text citations, and references.

8. INCONSISTENCIES MUST BE AVOIDED. Be sure you are *consistent* in your use of abbreviations, terminology, and in citing references, from one part of your paper to another.

9. PREPARATION OF TABLES, FIGURES, AND ILLUSTRATIONS. Any material that is not textual is considered artwork. This includes tables, figures, diagrams, charts, graphs, illustrations, appendices, screen captures, and photos. Tables and figures (*including* legend, notes, and sources) should be no larger than 4 1/2 x 6 1/2 inches. Type styles should be Helvetica (or Helvetica narrow if necessary) and no smaller than 8 point. We request that computer-generated figures be in black and white and/or shades of gray (preferably no color, for it does not reproduce well). Camera-ready art must contain no grammatical, typographical, or format errors and must reproduce sharply and clearly in the dimensions of the final printed page (4 1/2 x 6 1/2 inches). Photos and screen captures must be on disk as a TIFF file, or other graphic file format such as JPEG or BMP. For rapid publication we must receive black-and-white glossy or matte positives (white background with black images and/or wording) in addition to files on disk. Tables should be created in the text document file using the software's *Table* feature.

10. SUBMITTING ART. Both a printed hard copy and a disk copy of the art must be provided. We request that each piece of art be sent in its own file, on a disk separate from the disk containing the manuscript text file(s), and be clearly labeled. We reserve the right to (if necessary) *request new art, alter art*, or if all else has failed in achieving art that is presentable, *delete art*. If submitted art cannot be used, the publisher reserves the right to redo the art and to change the author for a fee of \$35.00 per hour for this service. The Haworth Press, Inc. is not responsible for errors incurred in the preparation of new artwork. Camera-ready artwork must be prepared on separate sheets of paper. Always use black ink and professional drawing instruments. On the back of these items, write your article title and the journal title lightly in soft-leaf tencil (please do not write on the face of art). In the text file, skip extra lines and indicate where these figures are placed. Photos are considered part of the acceptable manuscript and remain with the publisher for use in additional printings.

11. ELECTRONIC MEDIA. Haworth's in-house typesetting unit is able to utilize your final manuscript material as prepared on most personal computers and word processors. This will minimize typographical errors and decrease overall production time. Authors are encouraged to submit electronic disks to Social Work in Mental Health. The manuscript should be on a virus-free disk and only the article should be on the disk. Please put the manuscript (text, references, and figure legends) in one file. Identify the disk by providing the journal name, the first author's name, the name of the computer file, the type of hardware (e.g., Macintosh or PC), operating system and version (e.g., Windows 95), and software program and version used (e.g., Word 97). Tables and figures should not be on the disk, rather they should be submitted traditionally in hard format.

NOTE: Disk and hard copy must agree. In case of discrepancies, it is The Haworth Press' policy to follow hard copy. Authors are advised that *no revisions* of the manuscript can be made after acceptance by the editor for publication. The benefits of this procedure are many with speed and accuracy being the most obvious. We look forward to working with your electronic submission which will allow us to serve you more efficiently.

12. ALTERATIONS REQUIRED BY REFEREES AND REVIEWERS. Many times a paper is accepted by the editor contingent upon changes that are mandated by anonymous specialist referees and members of the editorial board. If the editor returns your manuscript for revisions, you are responsible for retyping any sections of the paper to incorporate these revisions (if applicable, revisions should also be put on disk).

13. TYPESETTING. You will not be receiving galley proofs of your article. Editorial revisions, if any, must therefore be made while your article is still in manuscript. The final version of the manuscript will be the version you see published. Typesetter's errors will be corrected by the production staff of The Haworth Press. Authors are expected to submit manuscripts, disks, and art that are free from error.
