Before preparing your submission, please consult the information below.

Papers for consideration should be sent to the Editor. **Electronic submission is preferred.** If submitting by mail (address given below), please include five good quality copies.

Note to authors: Please ensure your contact address is clearly visible on the outside of any material you send to Editors.

Papers are accepted for consideration on condition that you will accept and warrant the following conditions. In order to ensure both the widest dissemination and protection of material published in our Journal, we ask authors to assign the rights of copyright in the articles they contribute. This enables Taylor & Francis Ltd to ensure protection against infringement.

1. It is a condition of publication that authors vest or license copyright in their articles, including abstracts, in the *Australasian Society for the Study of Intellectual Disability Inc.* (ASSID). This enables us to ensure full copyright protection and to disseminate the article, and the journal, to the widest possible readership in print and electronic formats as appropriate. Authors may, of course, use the material elsewhere *after* publication providing that prior permission is obtained from the Editor or Taylor & Francis Ltd. Authors are themselves responsible for obtaining permission to reproduce copyright material from other sources.
2. We shall prepare and publish your Article in the Journal. We reserve the right to make such editorial changes as may be necessary to make the Article suitable for publication; and we reserve the right not to proceed with publication for whatever reason. In such an instance, copyright in the Article will revert to you.
3. You hereby assert your moral rights to be identified as the author of the Article according to the UK Copyright Designs & Patents Act 1988.
4. You warrant that you have secured the necessary written permission from the appropriate copyright owner or authorities for the reproduction in the Article and the Journal of any text, illustration, or other material. You warrant that, apart from any such third party copyright material included in the Article, the Article is your original work, and cannot be construed as plagiarising any other published work, and has not been and will not be published elsewhere.
5. In addition, you warrant that the Article contains no statement that is abusive, defamatory, libellous, obscene, fraudulent, nor in any way infringes the rights of others, nor is in any other way unlawful or in violation of applicable laws.

Early Electronic Offprints: Corresponding authors can now receive their article by e-mail as a complete PDF. Editorial Policy and Notes for Contributors

Purpose. The *Journal of Intellectual & Developmental Disability* (JIDD) is the official journal of the Australasian Society for the Study of Intellectual Disability (ASSID). JIDD is an international, multidisciplinary journal in the field of intellectual and developmental disability. The Journal publishes original qualitative and quantitative research papers, literature reviews, conceptual articles, Brief Reports, Case Reports, Data Briefs, and Opinions & Perspectives. JIDD also publishes book reviews written at the invitation of the Book Review Editor.

Submission. Submit all manuscripts, with a cover letter, to the Editor, Roger J. Stancliffe (Centre for Developmental Disability Studies, PO Box 6, Ryde, NSW 1680, Australia), e-mail: <rogerst@med.usyd.edu.au> **E-mail submission is preferred.** Include five good quality copies if submitting by mail.

Form. Authors should prepare manuscripts according to the *Publication Manual of the American Psychological Association* (5th ed.).

Text should be double-spaced. Instructions for preparing tables, figures and references appear in the *Manual*. All manuscripts (except *Data Briefs* and *Opinions & Perspectives*) must include a Structured Abstract of 100-150 words typed on a separate sheet of paper with appropriate sub-headings: *Background, Method, Results, Conclusions*. These should outline the questions investigated, the design, essential findings and main conclusions of the study. A cover sheet should include title, running head (not exceeding 40 characters), author(s), affiliation(s), author note, and address (including an e-mail address) for correspondence. As manuscripts are reviewed anonymously, the running head (rather than the author's name), should appear as a header on each subsequent page and other identifying material should be omitted from the manuscript.

Length. The suggested maximum length (double-spaced pages) for each type of submission is as follows: *Full-length articles* – 20 pages (including references, tables and figures); *Brief Reports* and *Case Reports* - 8 pages; *Data Briefs* and *Opinions & Perspectives* - 5 pages. Manuscripts exceeding these limits may be accepted depending on the importance and complexity of the content.

Terminology. JIDD uses *people first* language. The general form *person with a disability* is used rather than *disabled person*, so descriptions such as *a boy with Down syndrome* and *adults with spina bifida* are acceptable. As *normal* has multiple meanings, more precise terms such as *children without a hearing impairment* should be used. Generic descriptions such as *students, participants, and adults* are preferred to the term *subjects*. JIDD uses the term *intellectual disability* rather than *mental retardation* or *learning disability*.

Tables and Illustrations. Professional quality tables and figures should be presented on separate sheets and their approximate location in the text indicated. A signed release form must accompany any photographs of people. Care should be taken to conceal the identity of persons in photographs.

Colour figures.

- a. Any figure submitted as a color original will appear in colour in the journal's online edition free of charge and can be downloaded.
- b. Paper copy colour reproduction will only be considered on condition that authors contribute to the associated costs. Charges are: £500/US\$900 for the first colour page and £250/US\$450 for each color page after per article. (Colour costs will be waived for invited Review Articles)

Ethical Standards. Within the *Method* section, authors should explicitly address issues of ethical approval and informed consent, based on accepted ethical practices and procedures in their own country. Authors should disclose in an *Author Note*: (a) the source of all research funding, (b) whether the funding body has imposed any restrictions on free access to or publication of the research data, and (c) authors' financial and non-financial conflicts of interest, such as direct or indirect financial benefit.

Peer Review. All manuscripts are peer reviewed, with the exception of submissions to *Opinions & Perspectives*. The Editor (or the Associate Editor responsible for a manuscript) selects several reviewers from the JIDD Editorial panel to review each paper. If appropriate, a guest reviewer with specific expertise may be consulted. The process is anonymous in that the identity of authors and reviewers is not known to the other party. The Editor (or Associate Editor) then makes the final decision about acceptance for publication. The review process normally takes at least four months - longer when revision is necessary (revisions are often requested).

Data Sharing. Authors of data-based articles in JIDD should have their research data available for at least 5 years after publication. On request, these data should be shared with other competent professionals for reanalysis, solely for the purpose of verifying the published findings, provided that participants' confidentiality is protected and unless legal rights concerning proprietary data prevent their release. Where relevant, the specific computer program used for data analysis should be identified.

Opinions & Perspectives. This section provides a forum for discussion and debate about important current issues, innovations and policy perspectives in the form of short, well-reasoned, clearly written commentaries. No abstract is required. Submissions undergo editorial review (rather than peer review). Detailed editorial comments will not be provided on submissions that are not accepted.

Data Briefs. This section contains succinct summaries of significant current data (usually national data) on trends in demographics, service provision, expenditure, and other issues. Submissions are subject to peer review. No abstract is required.

Final Copy and Proofs. An electronic copy of the final version of manuscripts accepted for publication (in IBM [PC] format) will be required. A copy of the manuscript should be retained by the author for proof-reading purposes. A pdf proof of the copy-edited article will be e-mailed to the corresponding author for correction prior to publication.
