Journal *Clínica y Salud* is the publication entity for scientific expression of the Official College of Psychologists of Madrid (www.elsevier.es/clysa).

The Journal *Clínica y Salud* is an open-access journal with 3 regular issues. All articles are immediately and permanently accessible to facilitate their reading and download.

All original contributions will be evaluated anonymously (double blind) by external expert reviewers designated by the Editor.

The authors of the articles submitted to the journal do not make economic contributions neither for sending articles to the journal or for their publication, in which case the authors cede the article's copyright (transfer of copyright in these rules) but reserve their personal rights <https://www.elsevier.com/about/company-reported/policies/copyright>

The use by readers is regulated by the Creative Commons license: Attribution-Noncommercial-No Derivative Works (CC-BY-NC-ND). This license allows the reader to read, print, download and translate the article for exclusively personal use and/or share it with a third party, provided credit is given to the author, the version of the article is not modified and none of the uses of that article are for commercial (profit) motives.

Author Guidelines

Standards for the submission of originals

Manuscripts are to be submitted online using the website <http://ees.elsevier.com/clysa>

- a) The submission of a manuscript to the journal *Clínica y Salud* signifies that it has not been simultaneously submitted to another journal and has not been previously published in another location.
- b) The journal adopts the publication standards and style of the APA, a manual published by the American Psychological Association of Washington DC, USA (<http://www.apastyle.org>).
- c) **Originals.** Manuscripts must have a maximum length of 20 pages, are to be written in Times New Roman, double spaced, with wide margins (e.g., 2.5 cm on each side), with all pages numbered (including the title page), with the tables at the end of the manuscript, attached on separate pages, indicating in the text the approximate location where they should be attached. The tables are to be created with tabs and without grids. Manuscripts must include an abstract of the content of no more than 150 words. If the original is in Spanish, an abstract in English must also be sent. Manuscripts in Spanish must include (at the end of the text and before the references) an extended abstract in English, in which a broad abstract of the study's content is presented, especially in terms of the problem studied, the method, the results and the discussion. This extended abstract must not include tables, figures or graphs; if these are needed, however, then references to them shall be made. The extended abstract must have a length of 1500-2000 words. The manuscripts written in English must not include the extended abstract.
- d) **Brief Articles.** These consist of a summary statement of an empirical study structured as follows: Introduction, Method, Participants, Instruments, Procedures, Results and Discussion. After these sections come the acknowledgements and references. The maximum length of the text must be 6 DIN-A4 pages, and up to 3 tables or figures will be accepted. The maximum number of references is 15. Include a 150-word abstract.
- e) **Letters to the Director.** These will make reference to published studies in the journal *Clínica y Salud* and provide opinions, observations or experiences that, due to their characteristics, can be summarised in a brief text. The maximum length will be 2 DIN-A4 pages of text, without an abstract, and including a maximum of 5 references.
- f) **Book Critique.** The journal will publish book critiques that are relevant for the scope of Clinical and Health Psychology. The maximum length will be 2 DIN-A4 pages.

- g) **Opinion Articles.** These articles present the author's opinion on a topic of the specialty, focusing on their personal lines of thoughts on the topic. The author may refer to related publications. One or 2 authors may sign these articles. Do not include an abstract. These articles generally have no sections. The maximum length is 6 ID-A4 pages, excluding the references (maximum of 15 citations).
- h) **Clinical Cases.** Clinical cases shall have a maximum length of 6 DIN-A4 pages, and up to 15 references and up to 2 tables or figures will be accepted.
- i) For any of the types of documents that are submitted to journals for consideration, the graphs and figures, if any, must be included at the end of the document, on separate pages and after the tables. Their approximate location must also be indicated. The graphs must be created in grayscale.
- j) The first page of every manuscript must include the study title, which, if it is in Spanish, must include its English translation. The page must also include an abbreviated title, the name(s) of the author(s), with their corresponding affiliation (not their postal address), keywords (in Spanish and English), the address for correspondence and any other information regarding the preparation of the manuscript or acknowledgements that the author(s) wish(es) to make and are of interest, always in a summarised fashion.
- k) The authors are responsible for obtaining written permission for all material that might be protected by copyright that they want to reproduce in the article, including but not limited to figures, graphs and tables.
- l) **Funding.** The authors must declare the source of any financial or technical assistance received. This funding must be reflected in the manuscript.
- m) Before a manuscript can be published, the author(s) must transfer the manuscript's copyright to the Official College of Psychologists of Madrid by signing the corresponding form, leaving the authors with the intellectual property rights over the articles. The Official College of Psychologists of Madrid authorises authors to use the material published by the Official College of Psychologists of Madrid and the intellectual property of these authors at any time without needing to request any permission, provided...
 - 1) Its use is for teaching purposes.
 - 2) Its use does not represent any financial transaction (lease, procurement, sale or any other type of mercantile exchange).
 - 3) The material is properly referenced, and the Official College of Psychologists of Madrid is recognised as the publishing entity.
 - 4) There is an indication that the material is subject to copyright.

If these conditions are not met, authorisation for the use of material published in the journal cannot be granted.

Copyright Transfer

Once the article has been accepted, the corresponding author will receive a link to the online version for signature for the transfer of copyright to [Official College of Psychologists of Madrid], with the power to transfer the rights to third parties, as well as the signing of the Creative Commons license: Recognition – Noncommercial – No derivative works (CC-BY-NC-ND: <http://creativecommons.org/licenses/by-nc-nd/4.0/>), which regulates the use by readers.

Authors who have received funding from the US National Institutes of Health or who belong to the Howard Hughes Medical Institute must agree to signing an exclusive license for the publication and distribution of their article, which will made be available online and subject to the conditions of use signed for in the Creative Commons license.
