



Instructions for Authors

Scope

The *Asian Journal of Social Science (AJSS)* is a principal outlet for scholarly articles on Asian societies published by the Department of Sociology, National University of Singapore. *AJSS* provides a unique forum for theoretical debates and empirical analyses that move away from narrow disciplinary focus. It is committed to comparative research and articles that speak to cases beyond the traditional concerns of area and single-country studies. *AJSS* strongly encourages transdisciplinary analysis of contemporary and historical social change in Asia by offering a meeting space for international scholars across the social sciences, including anthropology, cultural studies, economics, geography, history, political science, psychology, and sociology. *AJSS* also welcomes humanities-oriented articles that speak to pertinent social issues. *AJSS* publishes internationally peer-reviewed research articles, special thematic issues and shorter symposiums. *AJSS* also publishes book reviews and review essays of works published in various languages, research notes on Asian societies, and short essays of special interest to students of the region.

Ethical and Legal Conditions

Submission of an article for publication in any of Brills' journals implies the following:

1. All authors are in agreement about the content of the manuscript and its submission to the journal.
2. The contents of the manuscript have been tacitly or explicitly approved by the responsible authorities where the research was carried out.
3. The manuscript has not been published previously, in part or in whole, in English or any other language, except as an abstract, part of a published lecture or academic thesis.
4. The manuscript has not and will not be submitted to any other journal while still under consideration for this journal.
5. If accepted, the author agrees to transfer copyright to BRILL and the manuscript will not be published elsewhere in any form, in English or any other language, without prior written consent of the Publisher.
6. If the submission includes figures, tables, or large sections of text that have been published previously, the author has obtained written permission from the original copyright owner(s) to reproduce these items in the current manuscript in both the online and print publications of the journal. All copyrighted material has been properly credited in the manuscript. For more information on the reuse of figures, please go to brill.com/downloads/Rights-in-Images.pdf.

Online Submission

AJSS now uses online submission only. Authors should submit their manuscript online via the Editorial Manager (EM) online submission system at: editorialmanager.com/ajss. First-time users of EM need to

register first. Go to the website and click on the "Register Now" link in the login menu. Enter the information requested.

When you register, select e-mail as your preferred method of contact. Upon successful registration, you will receive an e-mail message containing your Username and Password. If you should forget your Username and Password, click on the "Send Username/Password" link in the login section, and enter your first name, last name and email address exactly as you had entered it when you registered. Your access codes will then be e-mailed to you.

Prior to submission, authors are encouraged to read the 'Instructions to Authors'. When submitting via the website, you will be guided stepwise through the creation and uploading of the various files.

A revised document is uploaded the same way as the initial submission. The system automatically generates an electronic (PDF) proof, which is then used for reviewing purposes. All correspondence, including the editor's request for revision and final decision, is sent by e-mail.

Double-blinded Peer Review

AJSS uses a double-blind peer review system, which means that manuscript author(s) do not know who the reviewers are, and that reviewers do not know the names of the author(s). When you submit your article via Editorial Manager, you will be asked to submit a separate title page which includes the full title of the manuscript plus the names and complete contact details of all authors. This page will not be accessible to the referees. All other files (manuscript, figures, tables, etc.) should not contain any information concerning author names, institutions, etc. The names of these files and the document properties should also be anonymized.

File Format

Please upload source files such as .doc, and not .pdf files.

Submission Requirements

The Editors are responsible for the selection and acceptance of articles, but responsibility for opinions expressed in them rests with the authors.

Language

Manuscripts should be written in English. Spelling (British or American) should be consistent

throughout.

Manuscript Length

Manuscripts submitted for publication in the journal must comply with the following: articles should be between 6,000 to 12,000 words; review essays, between 3,000 to 8,000 words and book reviews, between 800 to 1,000 words.

Manuscript Structure

Manuscripts must be double-spaced with wide margins.

The manuscript should be submitted as two files. The first file should contain the title, followed by the author(s)' name(s), title, affiliation and e-mail address(es). This should be followed by a brief biographical note and research interests, recent publications.

The second file should contain the manuscript, starting with the title, abstract, keywords, text and bibliography.

Abstract and Keywords

An abstract of 100-200 words should accompany papers, as well as up to five or six keywords.

Footnotes

Notes should be kept to a minimum and numbered consecutively throughout the article. Notes should be included as footnotes, and *not* as endnotes.

References in the Text

All source references are to be identified at the appropriate point in the text by the last name of the author, year of publication and pagination where needed. Identify subsequent citations of the same source in the same way as the first. Examples follow:

- If author's name is in the text, follow it with year in parentheses, e.g., Wong (1986).
- If author's name is not in the text, insert, in parentheses, the last name and year, e.g., (Duncan, 1986).
- Pagination follows year of publication after a colon, e.g., James (1979:56).
- Give both last names for two authors. Give all last names on first citation in text for more than two authors; thereafter use "et al." in the text. When two authors have the same last names, use identifying initials in the text. For institutional authorship, supply minimum identification from the beginning of the complete citation, e.g., (Malaysia, Department of Statistics, 1975).
- Separate series of references with semi-colons and enclose them within a single pair of parentheses, e.g., (Edwards, 1981; Lee et al., 1983).

Reference List

List all items alphabetically by author and, within author, by year of publication, in an appendix, entitled “References”. The use of “et al.” is not accepted in the appendix; list the names of all authors using full first names.

If there is more than one reference to the same author and year, distinguish them by the letters a, b, etc. after the year (2013a). The first letter of each word in an article title should be capitalized. The titles of books and journals should be in italics. Examples follow:

- Cramer, James A., ed. (1978) *Preventing Crime*. Beverly Hills: Sage Publications.
- Abraham, Itty (1996) “Science and Power in the Postcolonial State”, *Alternatives* 21(3): 321-339.
- Godelier, Maurice (1970) “System, Structure and Contradiction in Das Kapital”, in Michael Lane, ed., *Structuralism. A Reader*. London: Jonathan Cape, pp. 340-58.

Figures

All charts, maps and illustrations should be called “figures” and numbered consecutively; the number and title should be placed above the figure. Initial capitals should be used.

All figures and tables must be cited consecutively in the text.

Figures should be submitted as separate source files in .eps, .tif, or .jpg format, in a size suitable for the typesetting area of the journal. The resolution of these files should be at least 300 dpi for half-tone figures, and 600 dpi for line drawings. Number the files, and indicate in the manuscript where they are to appear (Fig. 1 here). All figures should be in black and white.

The text in a figure must be legible, and should not be smaller than corps 7. The size of this lettering for any text in a figure should be the same for all figures in the manuscript.

Publication

Proofs

Upon acceptance, a PDF of the article proofs will be sent to the author by e-mail to check carefully for factual and typographic errors. Authors are responsible for checking these proofs and are strongly urged to make use of the Comment & Markup toolbar to note their corrections directly on the proofs. At this stage in the production process only minor corrections are allowed. Alterations to the original manuscript at this stage will result in considerable delay in publication and, therefore, are not accepted unless charged to the author. Proofs should be returned to the Editor.

E-Offprints

A PDF file of the article will be supplied free of charge by the publisher to the author for their personal use. Brill is a RoMEO green publisher. Authors are allowed to post the pdf post-print version of their articles on their own personal websites free of charge. This means they can show the article exactly as it

appears in print. The institute employing the author is allowed to post the post-refereed, but pre-print version of articles free of charge on its repository. The post-refereed, pre-print version means the final accepted version of the manuscript before typesetting.

Consent to Publish

Transfer of Copyright

By submitting a manuscript, the author agrees that the copyright for the article is transferred to the publisher if and when the article is accepted for publication. For that purpose the author needs to sign the **Consent to Publish** which will be sent with the first proofs of the manuscript.

Open Access

In case the author wishes to publish the article in **Open Access** he/she can choose the **Brill Open** option, which allows for a non-exclusive Open Access publication in exchange for an Article Publishing Fee, and sign a special **Brill Open Consent to Publish**.
