Guidelines for Contributors:

The Canadian Geographer/Le Géographe Canadien publishes original, scholarly works in all fields of Geography. The submission of a manuscript is an implicit declaration that the work has not been published, in whole or in part, and is not being considered elsewhere. The Editorial Board considers a paper ineligible for publication if most of its content is:

- (i) under consideration for publication or is published in a journal, or book chapter;
- (ii) under consideration for publication or is published in a conference proceeding or a government publication, with a substantial circulation (distributed to 100 or more individuals over a wide area). Exceptions are possible if the author retains copyright and submitted manuscripts are substantially revised. For similar reasons, exceptions can be made for material published on the World Wide Web (Internet). Authors should contact the editor to discuss such manuscripts prior to submission.

TYPES OF SUBMISSION

Research articles: For editorial purposes, submissions are classified as Human Geography, Physical Geography or Geographic Information Science and are published in English or French. Research articles must report original and previously unpublished research or a development of a theory or technique that significantly extends knowledge within Geography. Research articles must be accompanied by abstracts in both English and French. Authors should limit the length of Research Articles to 5,000 to 15,000 words of text, including all text, tables, and illustrations. Special issues of Research Articles that focus on a selected theme may be published occasionally. The advice of the editor should be sought before undertaking a special issue.

Other types of submission are invited, notably:

Focus Essays: consist of a guest-edited selection of timely and original research reports that relate to a common theme or distinct specialization. The length of Focus Essays should be limited to 5000 words, including all text, tables, and illustrations. Those persons interested in organizing a submission are requested to describe their plans with the editor.

Review essays: are intended to provide an organized critical synthesis of information on an important topic. Readers are invited to submit manuscripts that interpret and evaluate the underlying themes from a current body of related literature or that review critically one or a number of major works in ways that go beyond the normal book review. Review essays should be no more than 4,000 words, including all text, tables, and illustrations. The advice of the editor should be sought before a reader undertakes a review essay.

Book reviews: are commissioned by the review editor to review individual books of importance to Canadian readership. Readers willing to undertake reviews are invited to send to the review editor a statement of the subject area(s) of interest to them. Unsolicited reviews may be accepted for publication, subject to external assessment.

Canadian Landform Examples: present succinct explanatory descriptions for teaching use or for raising research questions in geomorphology. Canadian Landform Examples should be limited to 3000 words, including all text, tables, and illustrations. The advice of the Canadian Landform Example editor should be sought before a reader prepares a submission.

Canadian Human Landscapes: offers interpretive perspectives on Canadian human landscapes. Canadian Human Landscape papers should be limited to 3000 words, including all text, tables, and illustrations. The advice of the Canadian Human Landscapes editors should be sought before a reader prepares a submission.

Commentaries: present a response to published articles or an editorial or scholarly opinion. Commentary articles are generally shorter essays, but longer manuscripts may be published after discussion with the editor. Commentaries should be limited to 1000 words or less. Commentaries are published at the discretion of the editor and they are peer reviewed by the editor and two editorial board members.

Obituaries: obituaries published in The Canadian Geographer conform to policies established by the CAG executive. For further information on obituaries, contact the editor.

SUBMISSION OF MANUSCRIPTS

Contributors of all kinds of submissions should submit their manuscripts electronically to TCG.editor@cag-acg.ca. Contributors will receive an email confirming the receipt of their manuscript that will include the manuscript tracking number. If the contributor does not receive a confirmation email, the contributor should follow-up with the Editor to make sure that their manuscript was successfully received. Manuscripts should be transmitted using a common word processing program, preferably Microsoft Word and, if the manuscript is accepted for publication, the author should be prepared to submit a second version as an RTF file.

At the time of submission corresponding authors should provide a letter that:

- (i) gives assurance that their manuscript represents original work that is not being considered for publication, in whole or in part, by another journal;
- (ii) states whether the manuscript is one of a kind, or part of a study or thesis from which other manuscripts may be generated;
- (iii) confirms that all of the authors have read and approved the manuscript; and
- (iv) provides the names of colleagues who have reviewed the manuscript in the final stages.

THE MANUSCRIPT

All parts of the manuscript, including footnotes, references, tables, and captions for illustrations should be typewritten and double-spaced with margins of 1 inch. Use italic font if available; where not available, underline material that is to be set in italics. Use capital letters only when the letters or words should appear in capitals in the printed paper. Each page of the manuscript should have the page number in the upper right-hand corner. The first page should have only the title, the authors' names, affiliations, telephone and fax numbers, and e-mail addresses, and any necessary footnotes. The title and abstract appears on the second page (please ensure that there are no authors' names after the first page), followed by the text and the reference list. Captions for tables and illustrations must be on separate pages and placed after the reference list. Text files and figure files should be submitted in separate electronic files. Please identify the word-processing software, version number, corresponding filenames and extensions, and type of computer used (IBM or Macintosh). For figures, refer to the section below on Illustrations. Please see the TCG Style Sheet for further details on issues of style and form.

Abstract

The abstract, typed on a separate page, should be headed by the full bibliographic reference. It should contain no more than 200 words. References should not be included unless they are absolutely essential and complete bibliographic information is given. The names of organisms should be in Latin and the authors cited. Abstracts are required in both English and French. Manuscripts will not be accepted for publication without French and English abstracts.

Acknowledgments

A statement headed Acknowledgments and not more than 100 words in length may be placed at the end of the text, immediately preceding the notes and/or references.

Footnotes

Footnotes should be designated by superscript Arabic numerals in serial order throughout the manuscript except in tables. Each footnote should be placed at the bottom of the manuscript page where reference to it is made. Footnotes should be kept to an absolute minimum and used only for necessary explanatory or parenthetical statements that would otherwise interrupt the flow of

argument in the main text. Footnotes should not be used for referencing sources (see instructions for references in the Style Sheet).

Preparation of electronic graphic files

Authors must supply copies of the original electronic files (i.e., the files directly from the software application that they were created in) and high-quality laser proofs of the images. Electronic files (i.e., fig. number and fig. content) should match the laser proofs and be submitted by e-mail once a manuscript has been accepted for publication. In the cover e-mail, please identify (i) the software application and version; (ii) file name(s), size, and extension; and (iii) if the files have been imported from another software. If you must compress your files, please use a compression format compatible with Stuffit. PC or Macintosh versions of True Type or Type 1 fonts should be used. Do not use bitmap or nonstandard fonts. All figures should be submitted at their final published size. For figures with several parts (e.g. a, b, c, d, etc.) created using the same software application, assemble them into one file rather than sending several files.

Permission to reprint

Whenever a manuscript contains material (tables, figures, charts, etc.) that is protected by copyright, it is the obligation of the author to secure written permission from the holder of the copyright to reproduce the material in both print and electronic formats. These letters must accompany the submitted manuscript.

Galley proofs

A galley proof, illustration proofs, the copy-edited manuscript, and a reprint order form are sent to the author. Galley proofs must be checked very carefully and must be returned within 48 hours of receipt. The proof stage is not the time to make extensive corrections, additions, or deletions, and the cost of changes introduced by the author and deemed to be excessive will be charged to the author.

Copyright transfer

All authors are required to complete a copyright transfer form assigning all rights to the Canadian Association of Geographers. Copyright transfer forms are available from the Editors. Requests for permission to republish the paper, in whole or in part, should be emailed to TCG.editor@cag-acg.ca
