

Sankhya, the Indian Journal of Statistics, comes out in two separate Series, namely Series A and Series B. The aim is to publish high quality research articles in the broad areas of Theoretical Statistics, Probability Theory and Stochastic Processes for Series A and Applied Statistics for Series B. The areas are to be interpreted in a broad sense. Theoretical articles are judged on the basis of their novelty and technical correctness. Applied articles should preferably include analysis of original data of broad interest, novel applications of methodology and development of methods and techniques of immediate practical use. Authoritative review articles and comprehensive discussion articles are also welcome.

*At the time of submission of a manuscript, **the authors should decide on the appropriate Series to which the submission is to be made, based on the broad coverage areas of the two Series as described above, and then make the submission accordingly.** In cases where a submitted manuscript is found by the Editors to be not suitable to be considered for the series to which the submission was originally made but perhaps suitable to be considered for the other series, it may be transferred for processing to that other series, after obtaining due consent from the author(s).*

Each submission to Sankhya undergoes an independent peer review. Only original research articles, which receive favourable reports (usually from one Co-Editor and at least one referee), are accepted for publication. Each volume of Sankhya has two issues of each series. The Series A issues come out in February and August, while the Series B issues come out in May and November. Sankhya articles are abstracted/reviewed in Statistical Theory and Method Abstracts, Mathematical Reviews and Zentralblatt fr Mathematik. No reprints of published articles are supplied by the journal. Author(s) of a published article receive one copy of the particular issue.

Manuscripts may be submitted in any one of the ways: (a) Four copies to Sankhya office; (b) PDF/Postscript file by e-mail or on a 3.5" DOS floppy disk;. Submitted manuscript must be unpublished work and must not be submitted/under consideration elsewhere for publication.

Manuscripts must be typed on one side, double-spaced with wide margins. Please consult the latest issue for style. Primary and secondary AMS subject classification numbers and some keywords and phrases should be mentioned at the bottom of the first page. A short title should be given for use as a running title. Present institutional affiliation for each author should be given after each author's name. A self-contained summary not exceeding 120 words is required. Diagrams should be in a form suitable for direct reproduction. Formulae should be numbered consecutively with numbers in brackets () appearing on the right margin. Tables should have short explanatory headings and be numbered as Table 1, Table 8, etc. References appearing in the text should be as Roy (1956), Morgan et al. (1972) etc. References at the end should be listed alphabetically. Permanent institutional address of each author should be given at the end. E-mail address if available should be included.
