INSTRUCTIONS FOR MANUSCRIPT SUBMISSION

General Information Manuscripts in German or English can only be submitted to the editors. All manuscripts will be peer reviewed. Manuscripts that are not along the lines below will be rejected and returned to the author for correction of the formal mistakes. Submission requires 3 copies. Receipt of the manuscript will be acknowledged in writing within 14 days. If this should not be the case, authors are requested to check with the editors.

The manuscript must be double spaced, with a wide margin, typed only on one side of the sheet. All manuscript pages, including references and legends must be numbered sequentially.

Title abbreviation of the journal for references: Z Gerontol Geriat

Page Limits Original articles as well as topical contributions should not exceed 10 to 12 manuscript pages of approximately 1.800 characters each (incl. tables, figures and references). At the end of the article should figure 5 essential statements, which are not meant to replace the abstract.

Short Contributions With appropriate topics it is possible to submit short contributions with a maximum of 2,5 manuscript pages (1.800 characters each, including figures, tables and references). In order to have citable contributions, such manuscripts, too, need to be submitted with a German and English Abstract and a maximum of 5 key words respectively.

Structure The first page of the manuscript should include: 1. Title of the article, 2. Name of all authors, 3. Footnotes to the title, 4. Complete addresses of all authors with identification (✉) of the corresponding author, 5. Column title (running title of the article for the page heading).

The *tables* are to be numbered independent of the figures with *Arabic* numerals, to be provided with headings, and to be kept separate from the text.

Figures must also be numbered with *Arabic* numerals and kept separate from the text. The legends must appear on a separate sheet. The desired placement of figures and tables is to be marked in the margin of the manuscript.

Electronic Files We request a diskette/CD-ROM for each manuscript. It should only be submitted after the reviewing process has been completed. Please observe the guidelines of the Technical Instructions (printed in most issues of this journal) when preparing your manuscript file.

Summaries/Zusammenfassungen and Key words/Schlüsselwörter A Summary of the essential statements both in English and German must precede each article, as well as an English Title. The Summary should be a short abstract as appropriate

for the needs of international documentation systems. At the same time the summary should be sufficiently comprehensive and detailed to inform the international reader. Inadequate summaries delay editorial processing of manuscripts. Below the summary the author must state up to 5 key words for documentation and indexing purposes in German and also in English.

References Only articles cited in the text are to be listed. They should be arranged alphabetically by the first author's name and numbered sequentially. *Only the reference number should appear in the text* (in square brackets).

Please do not list more than 30 literature references. Examples:

Figures If the author wants to re-use previously published material he is responsible to provide a permission by the copyright-holder.

Double presentation of the same information in tables and figures should be avoided. Short, clear legends make additional description in the text unnecessary.

The author is responsible for obtaining either from the patient or his legal representative permission for the reproduction of figures in which a patient can be recognized.

All material for figures must be identified on the back with the author's name and "top" or "bottom" (soft pencil - no stamp, no ink).

For general advice on the provision of figures please refer to the Technical Instructions in this issue.

Color illustrations will be accepted up to the discretion of the editors/the publisher.
